BACKGROUND: On March 27, 1984, the Board reinstated the Criminal Justice Advisory Committee with the following membership:

- 1) The Sheriff
- 2) A Police Chief (Bradenton or Palmetto)
- 3) A Citizen (John Morey)
- 4) State Probation/Parole (LeRoy Jacoby)
- 5) A Judge (to be appointed by Chief Judge Dakan)
- 6) A County Commissioner
- 7) State Attorney (or a representative)
- 8) Public Defender (or a representative)
- 9) An Attorney (William C. Price III)

The Board also authorized the Committee to appoint its own chairman.

DISCUSSION: To complete representation on the Committee as authorized by the Board, a County Commissioner and a local police chief from Bradenton or Palmetto must be appointed.

RECOMMENDATION: Appointment of a County Commissioner to the Criminal Justice Advisory Committee. Appointment of one of the two police chiefs listed below:

- 1) Chief Hambacher, Palmetto
- 2) Chief C. Wells, Bradenton
