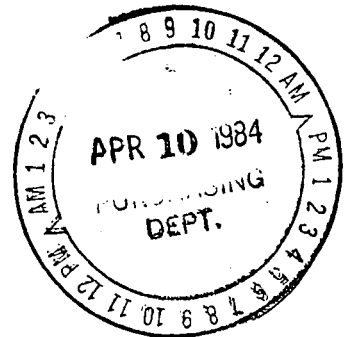

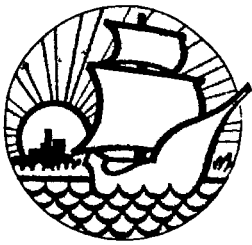

Purchasing solicited vendors for the referenced bid. A total of 38 vendors were sent intitations to bid. Only one (1) responsive bid was received.

Because of the extensive solicitation effort and since there appears to be little likelihood that rebidding would generate additional competition, Purchasing concurs with the department recommendation to award this bid to Rozier Machinery.

The total cost of the rental is \$38,080.00 which includes a one time delivery and pick-up charge, of \$280.00.
