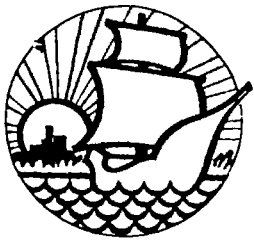

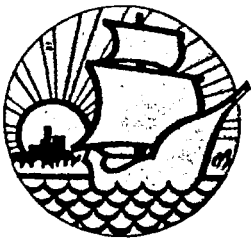
## PUBLIC OPENING

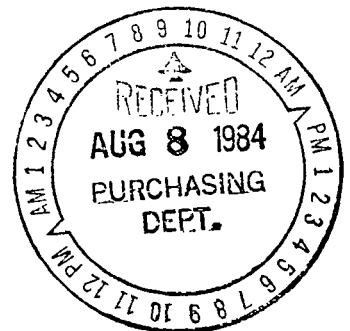
