

AN ORDINANCE OF THE COUNTY OF MANATEE, FLORIDA, AMENDING MANATEE COUNTY ORDINANCE 84-04 TO PROHIBIT THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 57TH AVENUE WEST (CR 48) FROM 21ST STREET WEST TO BRIDGE OVER CEDAR HAMMOCK; 65TH AVENUE DRIVE WEST FROM 9TH STREET WEST TO 12TH STREET WEST; 52ND AVENUE TERRACE WEST FROM 26TH STREET WEST TO 30TH STREET WEST; 61ST STREET WEST (PALM VIEW ROAD) 875' EAST OF U.S. 19 (SR 55) EAST 590' AROUND CURVE; 16TH STREET WEST FROM 53RD AVENUE WEST TO 55TH AVENUE WEST; 34TH STREET WEST FROM CORTEZ ROAD (SR 684) TO MIAMI PLACE, COUNTY MAINTAINED STREETS IN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

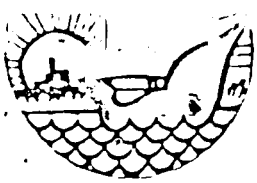

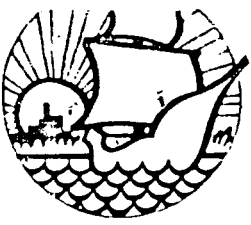

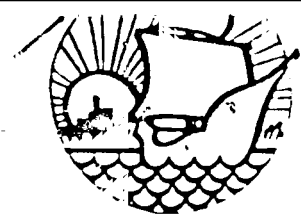
