BACKGROUND: For the past three years, the Human Services Division has administered the Chore Program with funding from the State of Florida, Department of Community Affairs through the Community Services Trust Fund grant. The following services are provided to Manatee County frail elderly residents age 60 or older: minor home repair, pest control, and heavy cleaning.

DISCUSSION: A grant funding Agreement which provides \$7,065 in State funds and includes \$7,065 in local match will make services available to over 245 persons. The local cash match has been budgeted in Fiscal Year 1985.

RECOMMENDATION: Authorize the Chairman to sign a funding Agreement with the State of Florida, Department of Community affairs, awarding Manatee County \$7,065 in State funds to provide Chore Program for elderly services from October 1, 1984 through September 30, 1984.
