RECOMMENDATION

Adoption of Resolution No. R-90-71, a Resolution of the Board of County Commissioners, Manatee County Florida, adopting the Manatee County Impact Fee Schedule.

BACKGROUND

Impact Fee Ordinance 86-09 has become Chapter 8 of the Manatee County Land Development Code (LDC), Ordinance 90-01 with an effective date of October 15, 1990. Chapter 8, Section 807.2 of Ordinance 90-01 establishes that the Board of County Commissioners shall adopt, by separate resolution, an Impact Fee Schedule which shall be reviewed by the County Administrator annually to reflect changes in construction and acquisition costs. The Impact Fee Schedule shall supersede Schedule "A" of Ordinance 86-09, as amended August 1989.

DISCUSSION

A new impact fee component, Law Enforcement, has been established in accordance with the provisions of Chapter 8, Ordinance 90-01 of the Manatee County Land Development Code (LDC), and shall become a part of Resolution R-90-71, Impact Fee Schedule.
