Approval of a Zoning Ordinance of the County of Manatee, Florida, amending the Official Zoning Atlas of Manatee County (Ordinance 90-01, the Manatee County Land Development Code), relating to zoning within the unincorporated area of Manatee County; providing for the rezoning of certain land from A-1 (Suburban Agriculture, 1 dwelling unit per acre) to GC (General Commercial); providing an effective date. IF APPROVED, the owner will be allowed to utilize the property for a range of commercial uses rather than agricultural related uses.

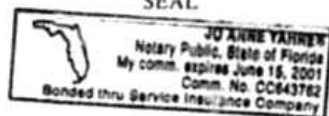

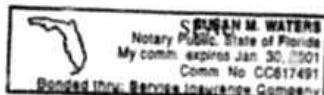
