

BACKGROUND/DISCUSSION:

- 11/06/90 VOTERS OF MANATEE COUNTY PASSED A REFERENDUM SUPPORTING A DEDICATED MILLAGE TO ENHANCE SERVICES TO CHILDREN IN MANATEE COUNTY.
- 07/09/91, MANATEE COUNTY ORDINANCE #91-42 WAS ADOPTED ESTABLISHING AN ELEVEN MEMBER CHILDREN'S SERVICES ADVISORY BOARD, AND DEFINING THE USAGE OF THE DEDICATED MILLAGE.
- 01/03/94, AT A JOINT WORK SESSION WITH THE BOARD OF COUNTY COMMISSIONERS AND CHILDREN'S SERVICES ADVISORY BOARD, STAFF WAS DIRECTED TO PROCEED WITH COORDINATING A CHILDREN'S SERVICES SUMMIT TO BE HELD AT THE MANATEE COUNTY CIVIC CENTER IN THE EARLY SPRING OF 1994.
- SINCE THIS TIME THREE CHILDREN'S SUMMITS HAVE TAKEN PLACE. DURING THIS PAST YEAR'S SUMMIT, OVER 4,700 MANATEE COUNTY RESIDENTS ATTENDED.
- THE SUMMIT PROVIDES AN OPPORTUNITY FOR MANATEE COUNTY RESIDENTS TO INTERACT AND EXCHANGE INFORMATION BETWEEN MANATEE COUNTY GOVERNMENT, TWENTY-THREE (23) DIFFERENT CHILDREN'S SERVICE AGENCIES, SEVEN (7) COMMUNITY CENTERS, AND IN THE PAST OVER FIFTY VARIOUS OUTSIDE VENDORS.
