- SEPTEMBER 7, 1992 PRESIDENT BUSH SIGNED THE JOB TRAINING REFORM AMENDMENTS OF 1992 WHICH REVISED THE JOB
  TRAINING PARTNERSHIP ACT (JTPA), PROVIDING OBJECTIVES AND ACTIVITIES OF STATE AND LOCAL WORKFORCE AGENCIES. THE
  JTPA IS A PARTNERSHIP BETWEEN LOCAL ELECTED OFFICIALS AND THE REGIONAL WORKFORCE DEVELOPMENT BOARD
  ESTABLISHED IN EACH SERVICE DELIVERY AREA (SDA).
- THE FLORIDA LEGISLATURE ESTABLISHED A STATE BOARD, ENTERPRISE FLORIDA JOBS AND EDUCATION PARTNERSHIP (JEP). IN 1994 BY SECTION 288.0475. FLORIDA STATUTES. THE STATE JEP WAS COMPOSED OF BUSINESS. LABOR, EDUCATION, COMMUNITY AND GOVERNMENT LEADERS. WORKING TOGETHER TO ASSEMBLE TRAINING PROGRAMS ONTO A CUSTOMER FOCUSED, MARKET DRIVEN, PLACEMENT BASED AND COMMUNITY MANAGED SYSTEM. JEP WAS DIRECTED BY GOVERNOR'S ORDER TO WORK WITH COMMUNITIES, COUNCILS AND AGENCIES, AND TO DEVELOP COMMUNITY MANAGED PLANS TO COORDINATE ONE-STOP CENTERS WHERE DIVERSE WORKFORCE RESOURCES WOULD BE ASSEMBLED INTO SINGLE SERVICE ENTITIES.
- A JOINT POWERS AGREEMENT BETWEEN MANATEE COUNTY AND MANASOTA INDUSTRY COUNCIL, (MIC) WAS APPROVED BY THE
  MANATEE COUNTY BOARD OF COUNTY COMMISSIONERS ON JANUARY 27, 1996. THIS AGREEMENT. IN ACCORDANCE WITH THE
  JTPA LEGISLATION AND REGULATIONS SPECIFIED IN PUBLIC LAW 97-300 (JTPA), AS AMENDED, PROVIDED THAT MIC IS THE LOCAL
  JEP, THAT MIC DEVELOPS AND FUNCTIONS AS AN INDEPENDENT AGENCY. ESTABLISHES BY-LAWS AND POLICIES, AND COMPILES
  AND PUBLISHES A TWO-YEAR PLAN. TO INCLUDE THE GENERAL OBJECTIVES OF MIC AS WELL AS A DESCRIPTION OF ITS ACTIVITIES
  AND SERVICES. AND ANY ADDITIONAL GOVERNING CRITERIA.
- ON MARCH 6, 1996, AN INTERLOCAL AFREEMENT BETWEEN THE BOARD OF COUNTY COMMISSIONERS OF MANATEE AND SARASCTA COUNTIES WAS EXECUTED WHILH ESTABLISHED JOINT POLICIES FOR THE FORMATION AND FUNCTIONS OF THE MANATCE/SARASOTA JEP BOARD, THE LOCAL COORDINATING ENTITY. THE LOCAL JEP BOARD DETERMINED THAT IT SHOULD BE KNOWN AS THE SUNCOAST WOLLFORCE DEVELOPMENT BOARD (SWDB) AND SHOULD FUNCTION PURSUANT TO THE BY-LAWS OF THE MANASCTA INDUSTRY COUNCIL. ON MAY 14, 1996, THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY APPROVED AN ADDENDUM TO THE INTERLOCAL AGREEMENT TO RESTRUCTURE THE MANASCTA INDUSTRY COUNCIL AS THE SWDB. WHICH DEVELOPS COMMUNITY MANAGED PLANS TO COORDINATE ONE-STOP CENTERS. WHERE DIVERSE WORKFORCE RESOURCES ARE ASSEMBLED INTO SINGLE SERVICE ENTITIES.
- ON FEBRUARY 27, 1996, THE MANATEE COUNTY BOARD OF COUNTY COMMISSIONERS APPROVED THE INITIAL TWO YEAR PLAN, DEVELOPED IN ACCORDANCE WITH JIPA LEGISLATION AND REGULATIONS. THE BOARD APPROVED A MODIFICATION TO THE TWO-YEAR PLAN ON APRIL 1, 1997 IN ORDER FOR THE SWDB TO MORE ACCURATELY REFLECT SERVICE PROJECTIONS FOR PROGRAM YEARS, 1996, AND, 1997, TO INCORPORATE REGULATIONS UNDER WORKFORCE FLORIDA ACT OF 1996, AND, TO MEET REGULATIONS OF THE JOB TRAINING PARTINEPSHIP ACT.
- DUE TO THE EXPIRATION OF THE 1996 TWO YEAR PLAN, JTPA REQUIRES THAT A NEW PLAN BE DEVELOPED BY THE SWDB TO
  ASSESS NEEDS AND PROBLEMS IN THE LABOR MARKET THAT FORM THE BASIS FOR PROGRAM PLANNING. TO ENSURE ACCESS
  BY PROGRAM PARTICIPANTS, TO COORDINATE JOB DEVELOPMENT, PLACEMENT AND OUTREACH ACTIVITIES, AND TO ENTER INTO
  AGREEMENTS BETWEEN SERVICE DELIVERY AREAS TO PAY OR SHARE THE COST OF SERVICES. THE NEXT TWO YEAR PLAN WILL
  BE DEVELOPED IN 2000.
- JTPA LEGISLATION REQUIRES THAT A PLAN OR A SUMMARY BE DEVELOPED FOR LOCAL APPROVAL AND THEN SUBMITTED TO THE
  GOVERNOR'S OFFICE. CURRENT PROCEDURES, AS DIRECTED BY FLORIDA DEPARTMENT OF LABOR AND EMPLOYMENT SECURITY,
  DIVISION OF JOBS AND BENEFITS, HAS REQUESTED A SUMMARY, AND HISTORICALLY THIS HAS BEEN USED BY BOTH MANATEE
  AND SARASOTA COUNTIES' BOARD OF COUNTY COMMISSIONERS.
- PURSUANT TO JTPA LEGISLATION AND SUBSEQUENT JEP REGULATIONS, AUTHORIZATION IS ALSO REQUIRED FOR APPROVAL OF ATTACHMENT C TO THE TWO YEAR PLAN WHICH IS THE BI-ANNUAL DESIGNATION OF THE LUNCOAST WORKFORCE DEVELOPMENT BOARD AS THE LOCAL GRANTEE FOR ECONOMICALLY DISLOCATED WORKER ADJUSTMENT ACT (EDWAA) UNDER JTPA. AS PREVIOUSLY EXECUTED IN 1996 AND AMENDED IN 1997.
