BACKGROUND/DISCUSSION

- ▶ APRIL 21, 1998 - THE BOARD OF COUNTY COMMISSIONERS ADOPTED ORDINANCE 98-11, PROHIBITING STOPPING, STANDING, OR PARKING AT ALL TIMES ON SHEPHERD STREET AND HOLLY AVENUE, BASED UPON A PETITION RECEIVED FROM AN AREA RESIDENT. OTHER AREA RESIDENTS HAVE SINCE COMPLAINED THAT THE PETITION WAS NOT VALID, AND DID NOT REFLECT THEIR TRUE WISHES.
- ▶ MAY 5, 1998 - THE COMMISSIONER OF THE DISTRICT, UNDER COMMISSIONER'S COMMENTS, REQUESTED A RECONSIDERATION OF THE RESTRICTIONS IMPOSED ON HOLLY AVENUE AND SHEPHERD STREET BY ORDINANCE 98-11. STAFF WAS DIRECTED TO RETURN WITH THE NECESSARY MODIFICATIONS TO THE ORDINANCE. THIS WILL BE DONE BY ADOPTION OF ORDINANCE 98-30.
- ▶ JUNE 26, 1998 - STAFF HAS RECEIVED THE ATTACHED PETITIONS AND LETTERS IN SUPPORT OF THE PARKING RESTRICTIONS PROPOSED BY ORDINANCE 98 - 30
- ▶ JUNE 26, 1998 - STAFF RECOMMENDS FAVORABLE ACTION

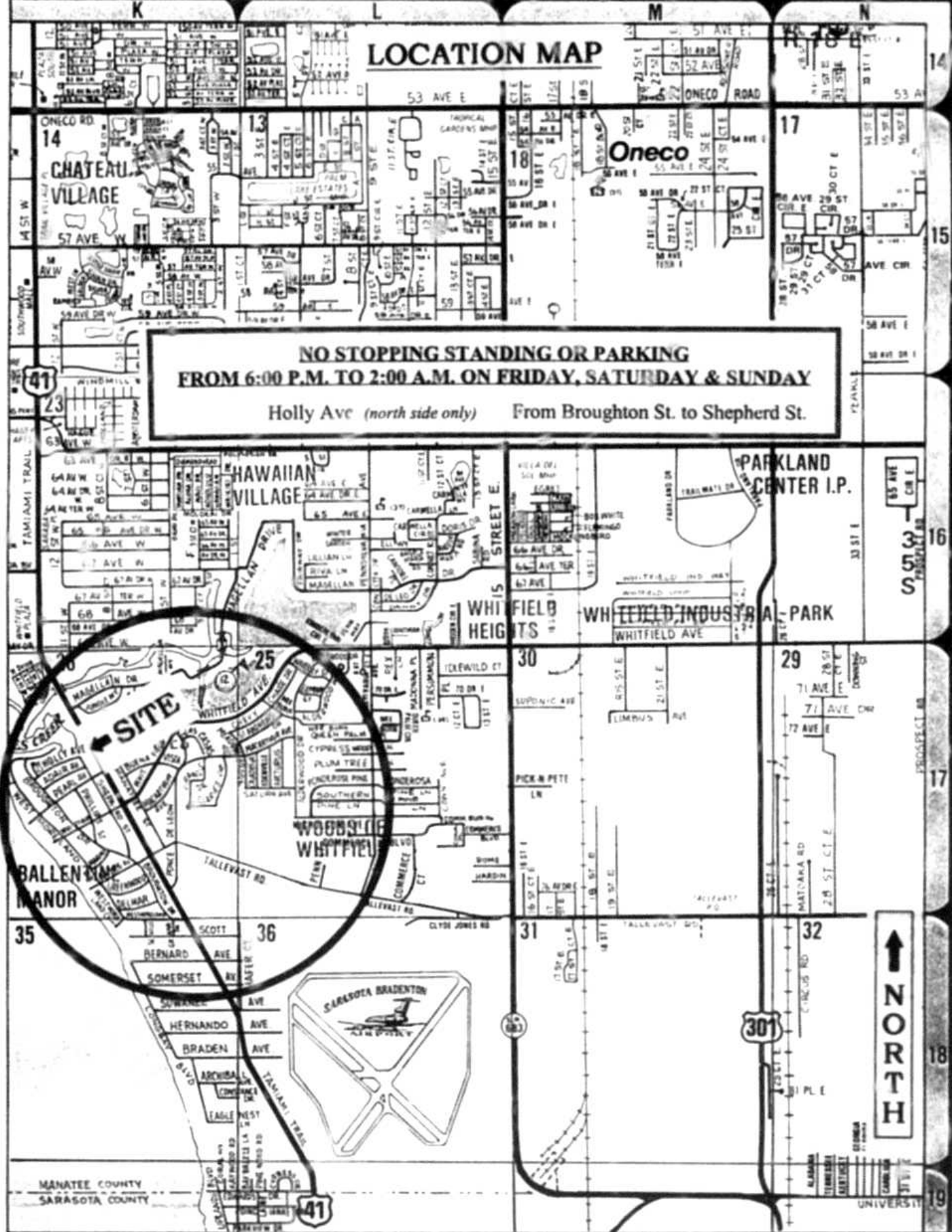

LOCATION MAP

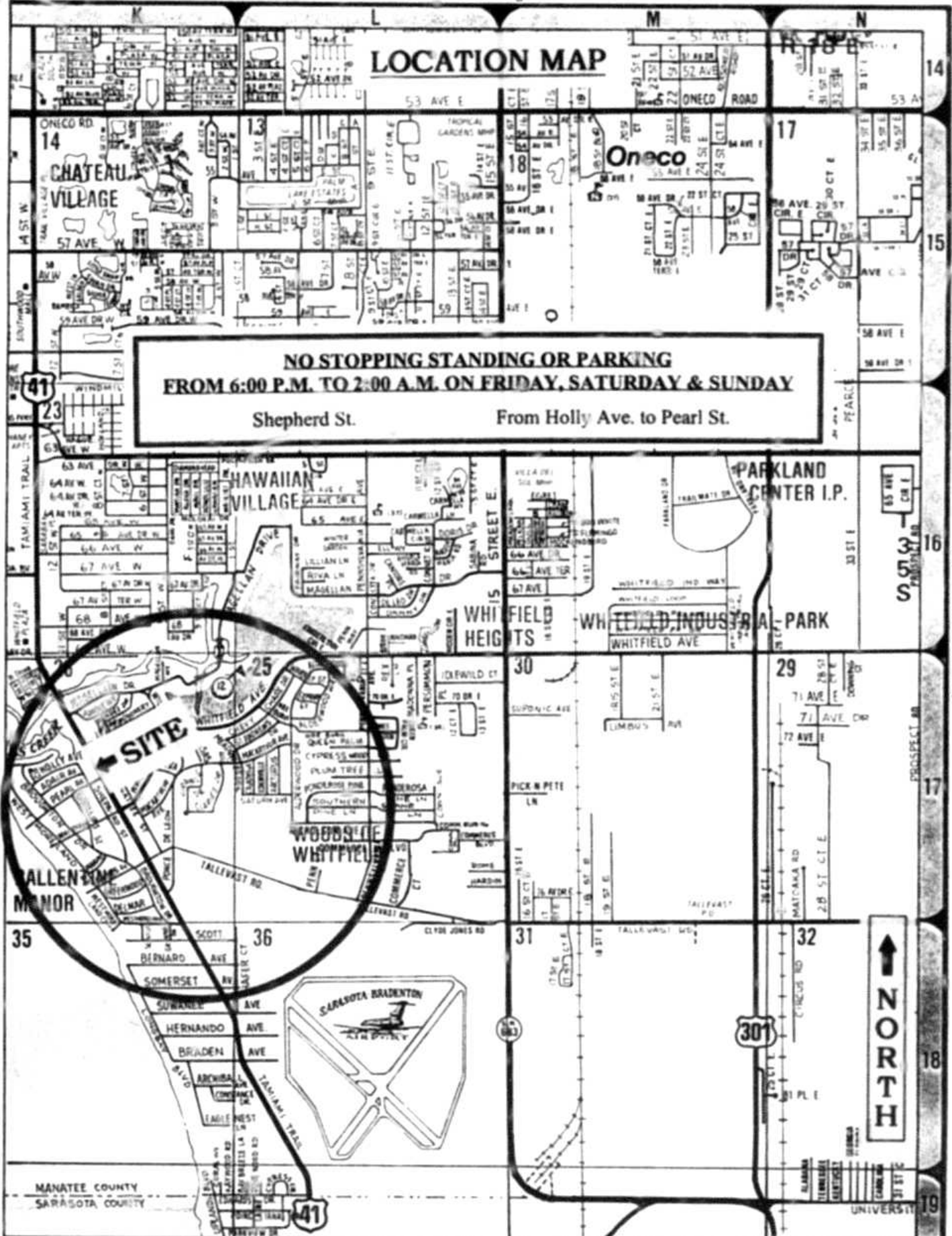
