TO 3:00 P.M., AT THE MANATEE CONVENTION AND CIVIC CENTER, THE MANATEE COMMUNITY COUNCIL FOR CHILDREN, PROJECT CHILD CARE, MANATEE PUBLIC HEALTH DEPARTMENT AND MANATEE COUNTY GOVERNMENT WILL BE PRESENTING THE FOURTH ANNUAL CHILDREN'S SUMMIT WITH THE THEME "FAMILIES RISING TO THE TOP."

WHEREAS, the purpose of this Summit is to provide a Community Forum to discuss the issues of Abused, Neglected, Abandoned, At-Risk and Economically Disadvantaged Children in Manatee County; and
