

WHEREAS, Civil Air Patrol, a civilian auxiliary of the United States Air Force, is dedicated to volunteer public service in the interest of community, state, and the national welfare; and,

WHEREAS, the members of SRQ Squadron, FL 044 are prepared to give of their time and resources for the benefit of their fellow Americans through aerial and ground search and rescue operations ("*Sundown Patrol*" flown on weekends and holidays), through humanitarian and mercy flights, and many other unselfish acts in time of emergency such as providing Color Guard for the Heritage Parade and the Manatee Tomato Festival, massing of the colors at Veterans' Day activities, working along side Manatee County Emergency Operations Center personnel in times of declared emergencies, assisting with other volunteers at "See Port Manatee" Day, as well as assisting at the air show at the Bradenton/Sarasota Airport honoring Veteran's Day; and,

WHEREAS, this organization of volunteers is helping conduct an effective national program of aerospace education and training for its members and the general public; and,

WHEREAS, this patriotic organization offers an outstanding program of leadership training and development and career motivation to its teenage cadet members; and,

WHEREAS, December 1, 1998 marks the 57th anniversary of the founding of this unique organization, established to help America in its hour of need during the dark day of World War II and which today is dedicated to the service of humanity and to the non-combatant defense of this nation.
