

**ADDENDUM NUMBER THREE
RFP#06-3341TC
AGREEMENT
PARKS ARCHITECTURAL / ENGINEERING SERVICES**

THIS ADDENDUM NUMBER THREE TO AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "County," with mailing address at 1112 Manatee Avenue West, Bradenton, Florida 34205, and CPH Engineers, Inc., hereinafter referred to as the "Consultant," duly authorized to conduct business in the State of Florida, with offices located at 3277 A Fruitville Road, Sarasota, Florida 34237.

WHEREAS, on August 8, 2007, the parties hereto entered into an Agreement for Parks Architectural / Engineering Services as provided for in this Agreement, hereinafter "the Agreement;" and

WHEREAS, pursuant to Article 5 of the Agreement, the Agreement shall remain in effect for a period of one (1) year but may be renewed for FOUR (4) additional periods, each of one (1) year; and

WHEREAS, the County has determined a need for the services beyond the one (1) year period ending August 7, 2010.

NOW THEREFORE, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

1. The duration of the Agreement shall be extended by one (1) year, commencing August 8, 2010 and ending August 7, 2011.
2. EXHIBIT "A" ADDENDUM NUMBER THREE – HOURLY FEE RATES and REIMBURSABLE replaces the ADDENDUM NUMBER TWO EXHIBIT "A" The ADDENDUM NUMBER THREE HOURLY FEE RATES and REIMBURSABLE REMAIN THE SAME AS SHOWN IN ADDENDUM NUMBER TWO.
3. All other terms and conditions of the Agreement shall remain in full force and effect during the term of the Agreement.

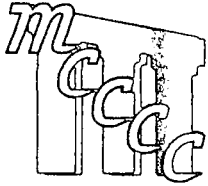

The above referenced Consultant Continuing Services Contracts are set to expire on August 7, 2010.



The Property Management Department estimates that the work during this extended period will not exceed \$500,000.00.

- On April 10, 2007, the Board of County Commissioners authorized negotiations with the four (4) top ranked firms for the purpose of entering into contracts to provide Parks Architectural and Engineering Services.
- August 8, 2007 the Board of County Commissioners executed Agreements with CPH Engineers, Inc.; IBI Group, Inc.; Wade Trim, Inc. and WilsonMiller, Inc. The Agreements are for an initial period of one (1) year with four (4) one (1) year extension options upon mutual agreement of the County and the Consultants.
- August 26, 2008 the Board of County Commissioners executed Addendum #1 extending the agreements for one (1) year from the day following the original expiration date for all four (4) firms. The FEE RATES established in Addendum #1 remained unchanged from the original one year period. A Principal of all four (4) firms was contacted by phone; each was asked to consider "freezing" their Fee Rates at the 2007/2008 level for Addendum #1 due to economic conditions and County budget cuts. All four (4) firms agreed with this request.
- July 28, 2009 the Board of County Commissioners executed Addendum #2 extending the agreements for one (1) year from the day following the original expiration date for all four (4) firms. The FEE RATES established in Addendum #1 remained unchanged from the original period. All four (4) firms were contacted and asked to consider "freezing" Fee Rates at the 2007/2008 level for Addendum #1 due to economic conditions and County budget cuts. All four (4) firms agreed with this request.
- Addendum #3 extends the agreement for one (1) year from the day following the Addendum #2 expiration date for three (3) firms. The County option to renew the fourth firm, Wade Trim, Inc., was not exercised. The FEE RATES established in the original Agreement shall remain unchanged. All firms named in this contract have agreed to engage in a twelve (12) month renewal at the same fees, terms and conditions as the original Agreement.
- The estimated range of cost per year for this agreement is approximately \$500,000. This range is based on an analysis of projected requirements for the duration of the agreement.
- These projects will be managed by Property Management Department.
