BACKGROUND/DISCUSSION

In April 2008, the Florida Department of Community Affairs and Florida Division of Emergency Management Division, selected Manatee County as a pilot community in a state wide initiative to develop guidelines for the development of the Post Disaster Redevelopment Plan (PDRP). The plan was intended to establish long-term planning policies regarding redevelopment, infrastructure, densities, non-conforming uses, and future land use patterns.

The PDRP was adopted by the BOCC on August 6, 2009 and will become part of a "Best Practices" guide authored by the Florida Department of Community Affairs for state wide distribution.

On June 11, 2010, the Manatee County Planning Department was honored to receive the 2010 FPZA Outstanding Public Study Award for the Post Disaster Redevelopment Plan (PDRP) from the Florida Planning and Zoning Association (FPZA). Sharon Tarman and Katie LaBarr accepted the award on behalf of Manatee County.
