**ADDENDUM NUMBER TWO
TO
AGREEMENT FOR HOUSEHOLD HAZARDOUS WASTE
COLLECTION AND DISPOSAL SERVICES**

THIS ADDENDUM NUMBER TWO TO THE AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "**County**," with a mailing address at 1112 Manatee Avenue West, Bradenton, FL 34205 and **Clean Harbors Environmental Services, Inc.**, hereinafter referred to as "**Contractor**", with offices located at 42 Longwater Drive, Norwell, MA 02061.

WHEREAS, on October 9, 2007 the parties hereto entered into and the Board of County Commissioners approved an Agreement for Household Hazardous Waste Collection and Disposal Services; and

WHEREAS, on October 7, 2009 the parties hereto executed Addendum Number One extending the Agreement for one (1) year commencing August 6, 2009 and terminating August 5, 2010.

WHEREAS, the Agreement may be renewed for three (3) additional one (1) year periods upon mutual agreement; and

WHEREAS, the Agreement may be amended upon mutual consent of the County and Contractor as evidenced by execution of an addendum; and

WHEREAS, the County has determined there is a need to continue these services; and

NOW THERE, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

1. The Agreement is extended commencing August 6, 2010 and terminating August 5, 2011.
2. All other terms and conditions of the Agreement shall remain in full force and effect.

The parties hereto have caused this Addendum Number Two to the Agreement for Household Hazardous Waste Collection and Disposal Services to be fully executed, in duplicate, by their authorized representatives.

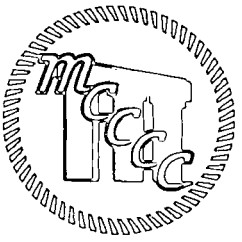
