THIS ADDENDUM NUMBER ONE TO AGREEMENT NO. 07- 4999RS, is made and entered into by and between the COUNTY OF MANATEE, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "County," with mailing address at 1112 Manatee Avenue West, Bradenton, Florida 34205, and Brasota Mortuary Transfer Inc., a Florida Corporation, with a mailing address at 509 15th Avenue West, Palmetto, FL 34221, hereinafter referred to as the "Contractor".

WHEREAS, on July 24, 2007, the parties hereto entered into an Agreement for the purpose of the Contractor providing removal and transport of deceased bodies, when necessary, throughout Manatee County, hereafter referred to as "the Agreement," and

WHEREAS, pursuant to Article 4 of the Agreement, the Agreement shall remain in effect for a period of one (1) year but may be renewed for FOUR (4) additional periods, each of one (1) year; and

WHEREAS, the County has determined a need for the services beyond the one (1) year period ending at midnight September 30, 2010.

NOW THEREFORE, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

- 1. The duration of the Agreement shall be extended by one (1) year, commencing October 1, 2010 and ending at midnight September 30, 2011.
- 2. The fees for this Addendum #3 shall remain unchanged and as shown in the original Agreement, all other terms and conditions of the Agreement shall remain in full force and effect during the term of this Addendum#3.

The parties hereto have caused this Addendum # 3 to Agreement for Body Removal and transportation Services to be fully executed, in duplicate, by their authorized representatives.

- On July 24, 2007 the BCC approved an Agreement for Body Transport within Manatee County to the Medical Examiner's office.
- On October 9, 2007 Amendment One, was presented to and approved by the BCC at the request of the Community Services Department to accomplish the following:
 - 1. Adding definitions for a "Call", "Removal and Transport", "Wait times", and a "Scene", will clarify the performance that is expected of the Contractor.
 - 2. It is more advantageous to the County to pay for the time that Brasota Mortuary Transfer (Brasota) spends at the scene waiting for governmental authority to remove the body, than paying for two visits to the scene in which Brasota may leave and return.
 - 3. The Community Services Department has requested that the Agreement be extended to September 30, 2008, matching the County's fiscal year cycle.
- Addendum #3 extended the agreement for one year from the day following the
 Addendum #2expiration date. The FEE RATES found in the original Agreement shall
 remain unchanged for this Addendum #3. The firms named in this contract has agreed to
 engage in a twelve (12) month renewal at the same fees, terms and conditions as the
 original Agreement.
- All other terms and conditions of the Agreement remain the same.
- This Agreement is managed by the Community Services Department.
