WHEREAS, Key Club International is a student led organization which provides its members with opportunities to provide service, build character, and develop leadership; and

WHEREAS, the Manatee High School Key Club was established in 1940 as a sponsored youth program of the Kiwanis Club of Bradenton; and

WHEREAS, the 150 members of the Manatee High School Key Club work to develop competent, capable, and caring leaders through the vehicle of service; and

WHEREAS, the major emphasis project of the Key Club was to "makeover" the home of a local family; and

WHEREAS, Key Club Members recruited volunteers, who donated over 2500 volunteer hours and raised over \$70,000 in cash and in-kind contributions for the completion of the "Extreme Home Keyover" project; and

WHEREAS, over 50 local businesses gave their time, talent, and treasure to the project which included a collaboration of public, private, religious, and education sectors of the community; and

WHEREAS, the Manatee High School Key Club improved the quality of life for a local family, inspired hope in a neighborhood, and taught by example the concept of service leadership to citizens in Manatee County, Florida and beyond.


