THIS ADDENDUM NUMBER FIVE TO AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, with mailing address at 1112 Manatee Avenue West, Bradenton, Florida 34205, hereinafter referred to as the "County," and **MILES MEDIA GROUP, INC.** with offices located at 6752 Professional Parkway West, Sarasota, FL 34240.

WHEREAS, on August 21, 2009 Addendum Number Three extended the agreement for one (1) year commencing October 1, 2009 and terminating September 30, 2010.

WHEREAS, on December 2, 2010 Addendum Number Four extended the agreement for one (1) year commencing October 1, 2010 and terminating September 30, 2011.

WHEREAS, the County has determined that there is need a to add additional services,

NOW THEREFORE, for and in consideration of the mutual benefits to be derived, the parties hereto agree to amend this agreement as follows:

1. The County hereby amends Exhibit "B" Rate Schedule and Compensation to include:

SilverPop Deployment Service @ \$0.01/email
2. All other terms and conditions of the Agreement shall remain in full force and effect during the extended term.





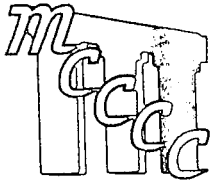
