**ADDENDUM NUMBER ONE  
TO  
ALZHEIMER'S DISEASE INITIATE (ADI)  
RESPITE SERVICE**

THIS ADDENDUM NUMBER ONE TO THE AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "**County**," with a mailing address at 1112 Manatee Avenue West, Bradenton, FL 34205 and **Tidewell Home Health LLC, Approved Home Health** hereinafter referred to as the "**Provider**", with offices located 4148 20<sup>th</sup> Street West, Bradenton, FL 34205.

**WHEREAS**, on June 17, 2010 the parties hereto entered into Agreement for Alzheimer's Disease Initiate (ADI) Respite Service for one (1) year commencing July 1, 2010 and terminating June 30, 2011 for a total not to exceed \$99,001 (FY 10/11); and

**WHEREAS**, the Agreement may be amended upon mutual consent of the County and Provider as evidenced by execution of an addendum; and

**WHEREAS**, the County has determined there is a need to incorporate the sale, assignment and assumption of this agreement as stated below; and

**NOW THERE**, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

1. The County acknowledges the sale, assignment and assumption of this agreement from Approved Home Health to Tidewell Home Health, LLC d/b/a Approved Home Health.
2. All other terms and conditions of the Agreement shall remain in full force and effect.

The parties hereto have caused this Addendum Number One to the Agreement for Alzheimer's Disease Initiate (ADI) Respite Service to be fully executed, in duplicate, by their authorized representatives.

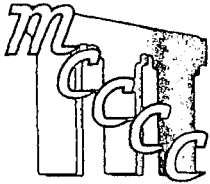
