

**ADDENDUM NUMBER SEVEN
TO
UNEMPLOYMENT INSURANCE COST CONTROL SERVICES**

THIS ADDENDUM NUMBER SEVEN TO THE AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, with mailing address at 1112 Manatee Avenue West, Bradenton, Florida 34205, hereinafter referred to as the "County" and **DEGROOT MANAGEMENT SERVICES, INC.**, duly authorized to conduct business under the laws of the State of Florida, with a mailing address at P.O. Box 502, Syracuse, NY 13214-0502 , hereinafter referred to as the "Contractor."

WHEREAS, on January 25, 2005, the parties hereto entered into an Agreement for Unemployment Insurance Cost Control Services; and

WHEREAS, the Agreement may be renewed for four (4) additional periods, each of one (1) year upon mutual agreement of County and Contractor as evidenced by execution of an addendum; and

WHEREAS, the parties authorized Addendums One, Two, Three and Four to extend the Agreement through December 31, 2009; and

WHEREAS, the parties authorized Addendum Five extending the Agreement from January 1, 2010 through June 30, 2010; and

WHEREAS, the parties authorized Addendum Six extending the Agreement from July 1, 2010 and terminating in December 31, 2010.

WHEREAS, the County has determined that there is a continuing need for the services and the Contractor has performed satisfactorily during the term of the agreement and;

NOW THEREFORE, for and in consideration of the mutual benefits to be derived, the parties hereto agree to amend this agreement as follows:


1. The County extends the Agreement for one (1) year beginning January 1, 2011 and terminating on December 31, 2011.



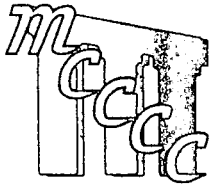
