

**ADDENDUM NUMBER THREE  
TO  
ALZHEIMER'S DISEASE INITIATE (ADI)  
RESPITE SERVICE**

THIS ADDENDUM NUMBER THREE TO THE AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "**County**," with a mailing address at 1112 Manatee Avenue West, Bradenton, FL 34205 and **Tidewell Home Health LLC, d/b/a Approved Home Health** hereinafter referred to as the "**Provider**", with offices located 4148 20<sup>th</sup> Street West, Bradenton, FL 34205.

**WHEREAS**, on June 17, 2010 the parties hereto entered into Agreement for Alzheimer's Disease Initiate (ADI) Respite Service for one (1) year commencing July 1, 2010 and terminating June 30, 2011 for a total not to exceed \$99,001 (FY 10/11); and

**WHEREAS**, on January 24, 2011 the parties hereto entered into Addendum Number One which acknowledged the sale, assignment and assumption of this agreement from Approved Home Health to Tidewell Home Health, LCC d/b/a Approved Home Health; and

**WHEREAS**, on February 3, 2011 the parties hereto entered into Addendum Number Two which increased the funded amount by \$4,006 (FY 10/11) for a revised total not to exceed \$103,007 (FY 10/11) funded amount; and

**WHEREAS**, the Agreement may be amended upon mutual consent of the County and Provider as evidenced by execution of an addendum; and

**WHEREAS**, the County has determined there is a need to increase the funded amount of the agreement.

**NOW THERE**, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

1. The County hereby increases the funded amount by \$9,795 (FY 10/11) for a revised total not to exceed \$112,802 (FY 10/11) funded amount.
2. All other terms and conditions of the Agreement shall remain in full force and effect.

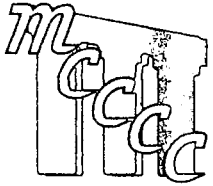
