**ADDENDUM NUMBER FIVE TO LICENSE AGREEMENT FOR BEVERAGE AND
SNACK FOOD VENDING MACHINE CONCESSIONS**

THIS ADDENDUM NUMBER FIVE TO THE AGREEMENT, is made and entered into by and between the COUNTY OF MANATEE, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "County," with a mailing address at 1112 Manatee Avenue West, Bradenton, FL 34205 and SNACKWORKS, INC., hereinafter referred to as the "Contractor", duly authorized to conduct business in the State of Florida, with offices located at 3109 59TH Ave. Drive East, Bradenton, FL 34203.

WHEREAS, on December 20, 2005 the parties hereto entered into an Agreement for Beverage and Snack Food Vending Machine Concessions commencing December 20, 2005 and terminating December 19, 2008; and

WHEREAS, on March 17, 2009 the parties hereto agreed to extend the agreement for one (1) year commencing December 20, 2008 and terminating December 19, 2009; and

WHEREAS, on January 5, 2010 the parties hereto agreed to extend the agreement for one (1) year commencing December 20, 2009 and terminating December 19, 2010; and

WHEREAS, on September 14, 2010 the parties hereto agreed to the sale of Bradenton Vending, Inc., to Snackworks, Inc. and adding services to Robinson Preserve;

WHEREAS, on January 6, 2011 the parties hereto agreed to extend the agreement for six (6) months commencing December 20, 2010 and terminating June 19, 2011 and incorporate vending at the Manatee County Judicial Center; and

WHEREAS, the Agreement may be amended upon mutual consent of the County and Provider as evidenced by execution of an addendum; and

WHEREAS, the County has determined there is a need to incorporate an extension; and

NOW THERE, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

1. Extends the agreement for sixty (60) days commencing June 20, 2011 and terminating August 19, 2011.
2. All other terms and conditions of the Agreement shall remain in full force and effect





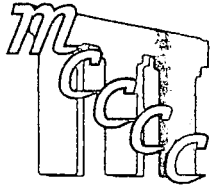
