WHEREAS on January 25, 2011 the parties hereto entered into Addendum Number One which acknowledged the sale, assignment and assumption of this agreement from Approved Home Health to Tidewell Home Health, LLC d/b/a Approved Home Health; and

WHEREAS on March 31, 2011 the parties hereto entered into Addendum Number Two increasing the funded amount by \$18,002 (FY 10/11) for a revised total not to exceed \$121,107 (FY 10/11); and

WHEREAS, the Agreement may be amended upon mutual consent of the County and Provider as evidenced by execution of an addendum; and

WHEREAS, the County has determined there is a need to extend the agreement; and

NOW THERE, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

- 1. The Agreement is extended for one (1) year commencing July 1, 2011 and terminating June 30, 2012 for a total not to exceed of \$108,120 (FY 11/12) for a revised total not to exceed \$229,227. The unit rate is \$18.02


