

**ADDENDUM NUMBER FOUR
TO
COMMUNITY CARE FOR THE ELDERLY (CCE)
PERSONAL CARE SERVICE**

THIS ADDENDUM NUMBER FOUR TO THE AGREEMENT, is made and entered into by and between the **COUNTY OF MANATEE**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the "**County**," with a mailing address at 1112 Manatee Avenue West, Bradenton, FL 34205 and **Tidewell Home Wealth, LLC d/b/a Approved Home Health** hereinafter referred to as the "**Provider**", with offices located 4148 20th Street West, Bradenton, FL 34205.

WHEREAS, on June 17, 2010 the parties hereto entered into Agreement for Community Care for the Elderly (CCE) Personal Care Service for one (1) year commencing July 1, 2010 and terminating June 30, 2011 for a total not to exceed \$89,005 (FY 10/11); and

WHEREAS, on December 10, 2010 the parties hereto entered into Addendum Number One increasing the funded amount by \$26,821 (FY 10/11) for a revised total not to exceed \$115,826 (FY 10/11); and

WHEREAS on January 25, 2011 the parties hereto entered into Addendum Number Two which acknowledged the sale, assignment and assumption of this agreement from Approved Home Health to Tidewell Home Health, LLC d/b/a Approved Home Health; and

WHEREAS, on March 31, 2011 the parties hereto entered into Addendum Number Three increasing the funded amount by \$38,883 (FY 10/11) for a revised total not to exceed \$153,709 (FY 10/11); and

WHEREAS, the Agreement may be amended upon mutual consent of the County and Provider as evidenced by execution of an addendum; and

WHEREAS, the County has determined there is a need to extend the agreement;

NOW THERE, for and in consideration of the mutual benefits to be derived, the parties hereto agree as follows:

1. The Agreement is extended for one (1) year commencing July 1, 2011 and terminating June 30, 2012 for a total not to exceed of \$137,311 (FY 11/12) for a revised total not to exceed \$291,020. The unit rate is \$22.51

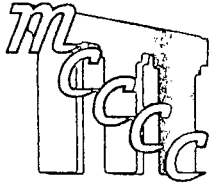
