***WHEREAS***, over the past several years, the National Coalition for the Homeless and the National Student Campaign Against Hunger and Homelessness have sponsored National Hunger and Homeless Awareness Week; and

***WHEREAS***, the Community Coalition on Homelessness in Bradenton has made the commitment to observe November 12-20, 2011 as Manatee County Hunger and Homeless Awareness Week; and

***WHEREAS***, the purpose of the week is to educate the public about the many reasons people are hungry and homeless, and to encourage support for homeless assistance service providers, for school service organizations and for community service opportunities for students; and

***WHEREAS***, the intent of National Hunger and Homeless Awareness Week is consistent with the activities of PATH, People Assisting the Homeless; and

***WHEREAS***, the theme of National Hunger and Homeless Awareness Week 2011 is "Bringing America Home," recognizing that unemployment and foreclosure issues have resulted in greater numbers of people becoming homeless due to loss of personal income and jobs; and

***WHEREAS***, the Board of County Commissioners recognize that hunger and homelessness continue to be a serious problem for many individuals and families in Manatee County.

***NOW, THEREFORE, BE IT PROCLAIMED*** by the Board of County Commissioners of Manatee County, Florida, that November 12-20, 2011, shall be known, designated, and set aside as
