

RESOLUTION B-13-050
AMENDING THE ANNUAL BUDGET
FOR MANATEE COUNTY, FLORIDA
FOR FISCAL YEAR 2012-2013

WHEREAS, Florida Statutes 129.06, authorizes the Board of County Commissioners to amend its budget for the current fiscal year as follows:

- a) Appropriations for expenditures in any fund may be decreased and other appropriations in the same fund correspondingly increased, provided the total appropriations of the fund are not changed.
- b) Appropriations from reserves may be made to increase the appropriation for any particular expense in the same fund, or to create an appropriation in the fund for any lawful purpose.
- c) Unanticipated revenues, including increased receipts for enterprise or proprietary funds, may be appropriated for their intended purpose, and may be transferred between funds to properly account for the unanticipated revenue.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida that the 2012-2013 budget is hereby amended in accordance with FS 129.06 as described on the attached summary and specified in the budget adjustment batch files which are listed below:

Department: PUBLIC SAFETY
Fund: GENERAL FUND
Description: Allocates \$812 from the Board's General Fund Reserve for Contingency to the General Fund General County account to pay the street waiver application fee for the Guardian Angels Foster Family Home project's request to rename the entry roadway as approved by the Board on May 7, 2013.

This action reduces the Board's Reserve from Contingency by \$812 to a revised total of \$1,149,188.

Background Discussion

- Edward Dick, on behalf of the Guardian Angels Foster Family Home project, is requesting a waiver of the street numbering requirement for the entry roadway into the project.
- The site contains 7.2650 +/- acres and the proposed development is residential homes for foster care families. Currently two homes are under construction, with the remaining seven homes to be constructed at a later date.
- The access roadway into the project currently has the numeric designation of 77th Ct E. However, the Guardian Angels Board would like to name the street "Bouwer Court," in honor of the Bouwer family, whose large financial contributions to the foster home project help make it possible.
- Section 742.8 of the Manatee County Land Development Code allows for a waiver of the street numbering requirement. This section also requires the Manatee County Public Safety Department, Traffic Management Division, and the North River Fire District to review the request.
- These reviewing agencies, with the exception of the North River Fire District, have no objection to the waiver request and have indicated that emergency response will not be compromised by the granting of the waiver.
- Guardian Angels Board has requested the County to pay the associated application fee of \$812

- County staff recommends that such refund and payment by County is appropriate and serves the public purpose of benefiting foster needs in the area
