

RESOLUTION NO. R-13-184

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, ESTABLISHING REVISED CONTRACTOR LICENSING, RENEWAL, EXAMINATION, AND ADMINISTRATIVE FEES AND CHARGES FOR UNINCORPORATED MANATEE COUNTY; ESTABLISHING REVISED CONTRACTOR LICENSING FEES FOR LOCAL LICENSES; ESTABLISHING REVISED CONTRACTOR LICENSING FEES FOR RENEWAL OF LOCAL LICENSES; ESTABLISHING REVISED ADMINISTRATIVE FEES AND CHARGES RELATED TO CONTRACTOR EXAMINATION AND LICENSING; PROVIDING DIRECTIONS REGARDING CODIFICATION; REPEALING AND SUPERSEDING CONFLICTING RESOLUTIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 489.117, Florida Statutes, authorizes counties, municipalities, and development districts to issue local licenses for contractors corresponding to the categories defined in Subsection 489.105(3), Florida Statutes, and for local specialty contractors; and

WHEREAS, Chapter 2-6, Article V, Code of Ordinances of Manatee County, Florida, provides rules and regulations for contractors in unincorporated Manatee County; and

WHEREAS, Section 2-6-73, Code of Ordinances of Manatee County, Florida, establishes requirements for contractors in unincorporated Manatee County, including payment of any applicable fees; and

WHEREAS, Subsection 2-6-76(a), Code of Ordinances of Manatee County, Florida, provides that fees for examination and licensing of contractors shall be established by resolution of the Board of County Commissioners; and

WHEREAS, the Manatee County Building and Development Services Department has reviewed and recommended approval of the contractor licensing, renewal, examination, and administrative fees and charges proposed in this resolution; and

WHEREAS, the Board of County Commissioners of Manatee County has determined that the contractor licensing, renewal, examination, and administrative fees and charges established in this resolution are reasonably related to the costs incurred by the County in providing such

services.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. Local contractor license fees. The Board of County Commissioners hereby establishes the following revised contractor licensing fees for local licenses in unincorporated Manatee County:

Section 2. Local contractor license renewal fees. The Board of County Commissioners

hereby establishes the following revised contractor licensing fees for renewal of local licenses in unincorporated Manatee County:

	<u>Annual Fee (per renewal)</u>
Regular (on or before September 30)	Same as applicable local license fee
Late (after September 30)	25% of applicable local license fee not to exceed \$50.00 plus fee for regular renewal

Section 3. Administrative fees and charges. The Board of County Commissioners hereby establishes the following revised administrative fees and charges related to contractor examination and licensing in unincorporated Manatee County:

<u>Service</u>	<u>Fee (per license)</u>
Application for local license	\$150.00
Scheduling examination for local license	\$25.00
Qualification file for state certified contractor (every even-numbered year)	\$80.00
File for nonlicensed trade (every even-numbered year) (tents, non-structural fences, demolitions)	\$80.00
Inactive status for registered or local specialty contractor (per year)	\$50.00
Inactive status for local license holder over 65 years of age	\$0.00
Inactive status for Manatee County employee	\$0.00

Section 4. Directions regarding codification. This resolution shall not be codified in the Manatee County Code of Resolutions.

Section 5. Conflicting resolutions. Effective October 1, 2013, all resolutions and parts of resolutions in conflict with the provisions of this resolution, including, but not limited to, Resolution No. R-12-57, shall be repealed, rescinded, superseded and replaced by this resolution to the extent of such conflict.

Section 6. Severability. In the event that any provision, portion or section of this resolution is determined to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining provisions, portions or sections of this resolution which shall remain in full force and effect.

Section 7. Effective date. This resolution and the fees and charges established in this resolution shall take effect October 1, 2013.
