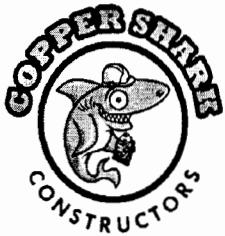
We had paid for replacement of the 5/8" meter to a 1" meter which was never completed. As the store is open and running smoothly we see no need to replace the meter and service at this juncture.

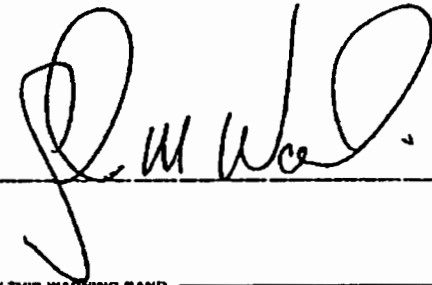
