

RESOLUTION R-17-113

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS, OF MANATEE COUNTY, FLORIDA, AUTHORIZING EXPENDITURE OF \$10,000 FOR MAJOR SPONSORSHIP OF THE MANATEE COUNTY FAIR ASSOCIATION.

WHEREAS, the Manatee County Fair is an annual event taking place in Manatee County, Florida, for the benefit of Manatee County Citizens; and

WHEREAS, the Manatee County Fair Association has requested funds of \$10,000 from the County in order to sponsor the Manatee County Fair; and

WHEREAS, Manatee County has been an active participant in sponsoring activities conducted at the fair which benefit the general citizenry of Manatee County; and

WHEREAS, the Board of County Commissioners of Manatee County, Florida has determined that participation in the 2018 Manatee County Fair is an appropriate expenditure.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee, Florida that:

1. Upon receipt of acceptable documentation, the Manatee County Clerk of the Circuit Court is hereby authorized to disburse funds in an amount not to exceed \$10,000, to the Manatee County Fair Association for Major Sponsorship during the 2018 Manatee County Fair.
2. The Financial Management Department or his designee shall be authorized to accept the appropriate documentation from the Manatee County Fair Association for payment of Major Sponsorship.
