ORDINANCE NO. 17-51

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, REGARDING PUBLIC FINANCE; AMENDING CHAPTER 2-29 OF THE MANATEE COUNTY CODE OF LAWS TO CLARIFY THE BOUNDARIES OF THE PORT MANATEE IMPROVEMENT DISTRICT; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Port Manatee and surrounding businesses provide vital economic opportunities for the people of Manatee County; and

WHEREAS, pursuant to Article VIII of the Florida Constitution and Chapter 125 of Florida Statutes, the County has established a Port Manatee Improvement District (the "District") to provide a financing mechanism to pay a portion of the costs of (a) reducing Port Authority debt obligations (b) port-related economic development, (c) infrastructure improvements within the District and expansion of Port Manatee, and (d) capital improvements to Port Manatee; and

WHEREAS, the County established the District pursuant to Ordinance No. 09-50, which included an attached description of the District boundaries, and which has been codified as Article XII of Chapter 2-29 of the Manatee County Code of Ordinances (the "Code"); and

WHEREAS, it is in the best interest of the public health, safety and welfare to adopt a new description of the District boundaries, and to amend certain provisions of the Code, to provide clarity to property owners within the District and to facilitate implementation of the District by public officials.

BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida:

Section 1. Purpose and Intent. This Ordinance is enacted to carry out the purpose and intent of, and exercise the authority set forth in, Article VIII of the Florida Constitution and Chapter 125, Florida Statutes, as amended.

Section 2. Findings. The statements contained in the recitals above are true and correct, and the Board of County Commissioners relies upon them as findings in the enactment of this Ordinance.

Section 3. Adoption of Revised Description of District Boundaries. The description of the District boundaries attached hereto as Exhibit "A" is hereby adopted, and replaces in its entirety the description of District boundaries attached to Ordinance No. 09-50.

Section 4. Amendment to Definition of Port Manatee Improvement District. The definition of Port Manatee Improvement District set forth in Section 2-29-138 of the Code is hereby amended as follows (underlined language added, strike-through language deleted):

Port Manatee Improvement District or district shall mean the district established pursuant to section 2-29-139 over that portion of the unincorporated area of the county described on Exhibit "A" attached to Ord. No. 17-51 and incorporated herein by reference.

Section 5. Amendment to Section 2-29-139 establishing the Port Manatee Improvement District. Section 2-29-139 establishing the Port Manatee Improvement District is hereby amended as follows (underlined language added, strike-through language deleted):

There is hereby established the Port Manatee Improvement District over that portion of the unincorporated area of the county shown on Exhibit "A" to Ord. No. 17-51 and incorporated herein by reference. The district shall have only those powers expressly conferred upon it pursuant to this Article XII, specifically the use of tax increment revenues for the purposes set forth in section 2-29-140. The Manatee County Board of County Commissioners ("board") shall act as the governing board of the district for the purposes of exercising the district's powers. The county administrator or his designee or designees shall act as the executive director and staff of the district for the purpose of carrying out the administrative functions required to exercise the district's powers.

Section 6. Codification. The publisher of the County's Code, the Municipal Code Corporation, is directed to incorporate the amendments in Sections 4 and 5 of this Ordinance into the Code.

Section 7. Severability. If any section, sentence, clause, or other provision of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining sections, sentences, clauses, or provisions of this Ordinance.

Section 8. Effective Date. This Ordinance shall become effective as provided by law.



Notice must be published in a newspaper of general circulation at least 10 days in advance of the hearing. Copies of the ordinance must be available for public inspection during the notice period. Attached is a draft notice that follows the County's standard form. Please coordinate with the agenda staff in the County Administrator's Office to schedule and advertise the ordinance.

Subject to the issues set forth above being addressed, I have no objection from a legal standpoint to the ordinance being scheduled for consideration by the Board. I express no opinion as to the business or policy judgment of adopting the ordinance.
