



Briefly describe the job duties of the nominee.

As the Supervisor of the Braden River Library, Cathy Laird is responsible for supervising a staff of 9 librarians and para-professionals, as well as the numerous volunteers who work at the library, and she does her job superbly. She takes an active role and typically works 3 or more hours each day at a public service desk; both reference and circulation. This is in addition to her responsibilities for branch administration, working closely with the library's Friends of the Library group, and serving on various committees. Because of her commitment to serving the public, she is well-known to the library patrons.

She is an excellent instructor to both staff and patrons. She competently assists patrons with computer problems, and she has served as a staff trainer many times, including the Gates Computer training and Polaris catalog training. When other branch libraries are in need of a substitute supervisor, Cathy is frequently chosen to take charge. She represents the library/NHS on county committees, including the Green Team, and was selected as a participant for the Library System's collaboration with the Harwood Institute and the Patterson Institute and was a member of the Community Conversation team at Lakewood Ranch Town Hall, and Library committees, such as the Long Range Plan, the Cross-Training team, Ask-A Librarian, Tutorials, and the county's Green Team. She edits the NovelList Fiction A-Z newsletter and is a frequent speaker to outside groups. Recently, she joined the Lakewood Ranch Kiwanis group to bring them the perspective of the Library System.

Describe the characteristics and job commitment/performance that makes this nominee excel above and beyond other county employees.

In the 19 years that Cathy has served the library system and Manatee County as the Braden River Library Supervisor, she has earned the respect and admiration of her coworkers, supervisors, staff from other departments, and the library patrons. When Cathy joined the Manatee County Public Library, she brought with her years of experience as a supervisor, children's librarian, cataloger and adult services librarian. In her years as branch supervisor, she has further honed these skills and developed her leadership abilities when she was chosen to attend the prestigious Florida Sunshine State Library Leadership Institute in 2012-2013. Drawing upon her leadership ability, she was selected to serve on the committee charged with writing the Library 5-year Plan to be submitted to the Florida State Division of Library and Information Services, and the subsequent long range plans. Cathy has a reputation for having mentored Braden River librarians who have gone on to supervisory positions at other Manatee County Library locations.

Substantiate why those characteristics justify this employee to be recognized as a Manatee County "Employee of the Month."

It takes a special person to grow a library from 6,000 volumes and 3 staff people to a library with 26,000 volumes, 9 staff and an average of 600 patrons coming in every day. In addition, running the largest branch library in Manatee County, where an item is checked out every 30 seconds, and the number of patrons served in 2016 was an astonishing 291,512 is not an easy job. Cathy is definitely this person.

She is level-headed, conscientious, and dedicated to rendering excellent customer service to each and every person coming into the library and to those she meets in the community. She trains her staff well, gives them responsibility for their tasks and trusts them to do them well. Her judgment is fair and impartial and she has a calm and unflappable demeanor. She is the "go-to" person when the other library supervisors have questions. Her staff is totally comfortable going to her for assistance for either work or personal concerns. They know that she will do her best to help in whatever way she can. Cathy is currently working with Neighborhood Services and Library administration, property management and architects to plan for future renovation of the Braden River Library. As the library grows to better serve the increasing needs of Manatee County's eastern residents, they can be assured that the Braden River Library is in the best possible hands.

How does this employee best exemplify the county's Mission Statement.

She is level-headed, conscientious, and dedicated to rendering excellent customer service to each and every person coming into the library and to those she meets in the community. She holds herself and her staff to the highest level of integrity. She models honesty and civility in her relationships to staff and public. She treats each library patron's requests and needs in a way that demonstrates their importance and value.

I have to say I was really honored when asked to write up a little something for the wonderful Cathy Laird! Though I was only under her supervision for less than 2 years, she was one of the best bosses I ever had, (I've had 11 so far!) She's conscientious and caring about not only her employees but her patrons as well. She is fair and hard working. In fact, she's so hard-working that she has amassed copious vacation time that she is forced to use it or lose it. She once used the word unflappable about one of her employees but I think that word applies to her as well. She navigates every obstacle that comes her way and faces it with an even keel. She knows her employees strengths and best assets. She was incredibly patient when I was learning how to use the register and the Horizon system. Even when I completely bungled things up, she never got upset. I never felt like I couldn't approach her. She is so deserving of this award. *Jennifer Morrison, Library Aide- Rocky Bluff Library*
