Stormwater Projects by Drainage Basin

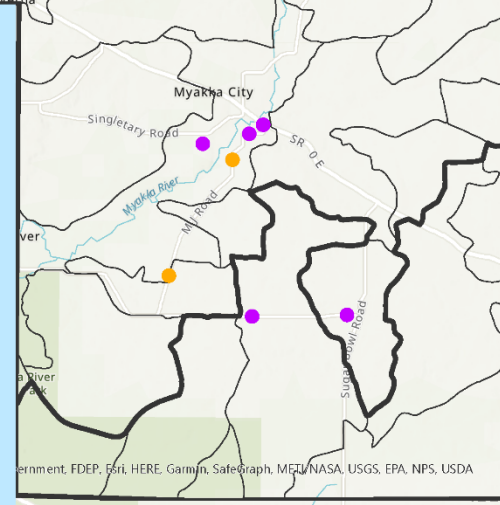

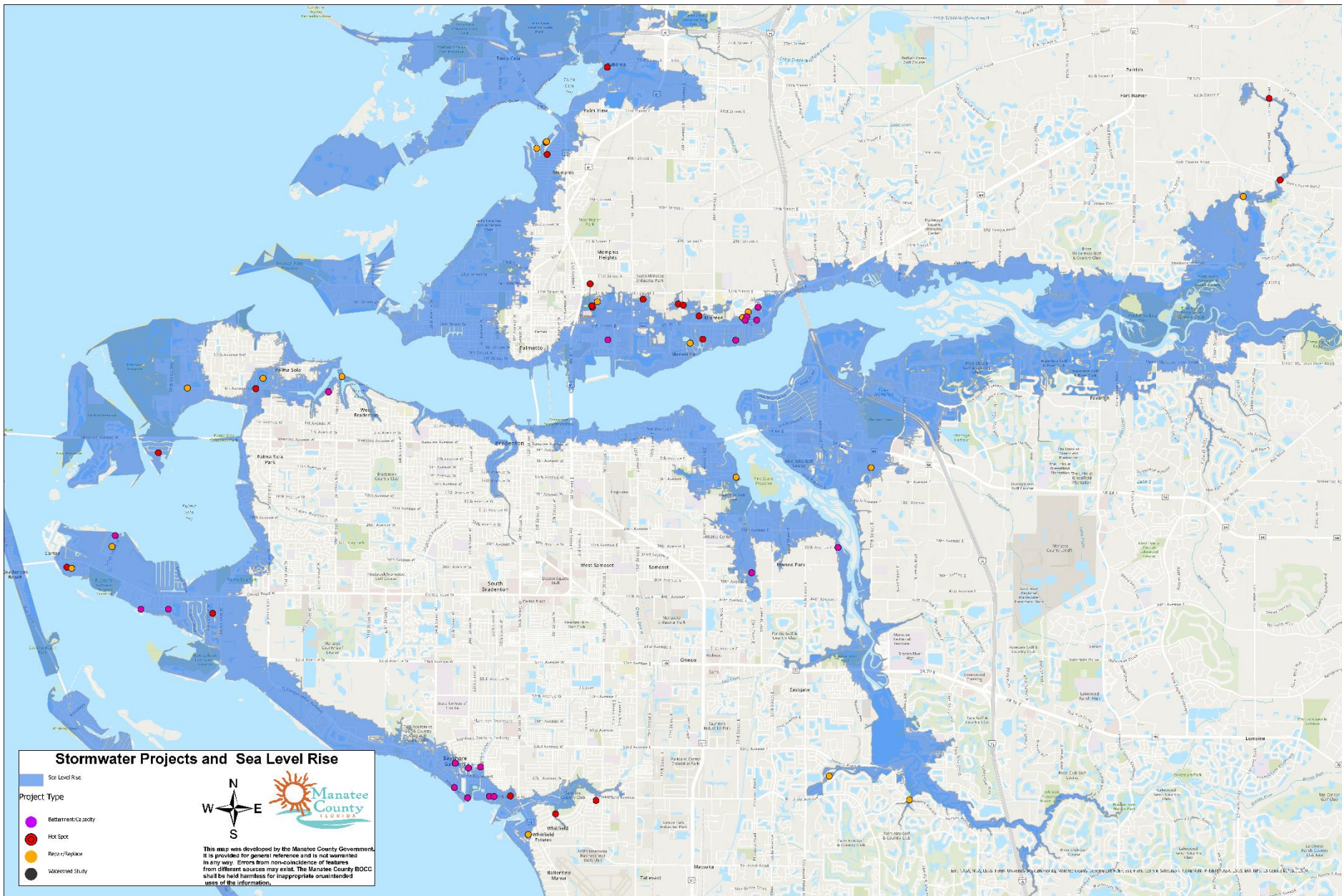
