THIS IS AMENDMENT NUMBER ONE TO THE Agreement, entered into and executed July 28, 2020, hereinafter referred to as "Agreement", between the County of Manatee, hereinafter referred to as "County", and Meals on Wheels Plus of Manatee, Inc., hereinafter referred to as "Provider."

WHEREAS, Provider is required under the Agreement to provide the Community Care for the Elderly Home Delivered Meal Program, hereinafter referred to as "Program", as set forth in Article 2, and Attachment B; and

WHEREAS, Article 3 and Attachment B, of the Agreement allocated \$77,000 for program clients during the term of the Agreement; and

WHEREAS, proposed figures contained in the FY 20/21 Agreement did not reflect the increased number of clients released from the waiting list needing this service; and

WHEREAS, shelf stable meals for hurricane season need to be provided; and

WHEREAS, an increase in the allocation to the Provider for the program will allow current clients to continue being served through the end of the contract period; and

WHEREAS, Article I I : Amendment provides that the Agreement may be amended only by written agreement executed by the governing bodies of both parties; and

WHEREAS, the County finds that it would be in the best interest of the citizens of Manatee County to amend the Agreement with the Provider.

WITNESSETH

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations contained in this Amendment, the parties here to agree as follows:

1. Article 3: Limitation of Costs and Payment: shall be amended as follows:

Provider shall be paid by County an amount not to exceed \$78,848.00 in accordance with Attachment B for the Provision of the Program

2. Page B1, Attachment B, Payments: Paragraph 1 .A., shall be amended as follows:

Provider shall be paid for the actual number of units of service it has provided in an amount not to exceed \$78,848.00 for Home Delivered Meals as specified below.

All other terms and conditions of the Agreement remain in full force and effect during the remainder of the Agreement.

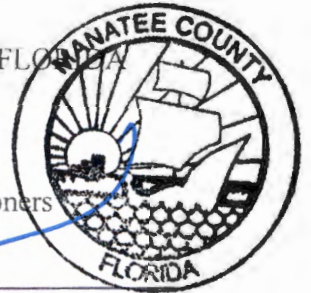

Authorization for the Chairperson to execute Amendment No. 1 to the state FY 20/21 Community Care for the Elderly funding agreement with Meals on Wheels Plus of Manatee, inc., amending the agreement to change the contract total from \$77,000 to \$78,848 for the service of Home Delivered Meals.

Background Discussion

- Amendment 1 increases the funding for Home Delivered Meals by \$1,848 for a total not to exceed \$78,848.
- Amendment 1 will allow for active clients in the program to continue to receive their home delivered meals through the end of the contract year which is June 30, 2021.
- Amendment 1 will allow for the purchase of some hurricane shelf stable meals to be delivered to seniors enrolled in this program.
- Manatee County has served as Lead Agency for the Community Care for the Elderly grant program for over thirty years.

- Grant funds are provided by the state through the Senior Connection Center, Inc., to provide services such as Case Management, Homemaker, Personal Care, and Home Delivered Meals to persons sixty years of age or older to prevent or delay institutional placement.
