AMENDMENT NO. 5 TO AGREEMENT NO. 18-R069731GL FOR CONSTRUCTION OF ADA COMPLIANT BUS STOP LANDING PADS, WALKWAYS, SIDEWALKS, SHELTER PADS AND BENCH PADS

This Amendment No. 5 to Agreement No. 18-R069731GL (hereinafter Amendment) is made as of this 7th day of June 2021 (hereinafter Effective Date) between Manatee County, a political subdivision of the State of Florida, with its principal place of business located at 1112 Manatee Avenue West, Bradenton, FL 34205 (hereinafter County) and Gator Grading & Paving, LLC, a Florida Limited Liability Company, whose address is 2704 105th Street East, Palmetto, FL 34221 (hereinafter Contractor).

WHEREAS, on December 20, 2018, the County entered into Agreement No. 18-R069731GL with Gator Grading & Paving, LLC for the Construction of ADA Compliant Bus Stop Landing Pads, Walkways, Sidewalks, Shelter Pads and Bench Pads in the annual not-to-exceed amount of \$300,000.00 (Initial Agreement); and

WHEREAS, on January 24, 2020, the parties hereto entered into Amendment No. 1 to extend the Agreement by one (1) additional year, commencing December 20, 2019 and ending December 19, 2020; and

WHEREAS, on May 28, 2020, the parties hereto entered into Amendment No. 2 to amend Exhibit B, Fee Rate Schedule; and

WHEREAS, on August 11, 2020, the parties hereto entered into Amendment No. 3 to add Ramirez Concrete Inc., as an approved subcontractor and amend Exhibit B, Fee Rate Schedule; and

WHEREAS, on February 17, 2021, the parties hereto entered into Amendment No. 4 to extend the Agreement by one (1) additional year, commencing December 20, 2020 and ending December 19, 2021; and

WHEREAS, the County has determined a need to extend the agreement; and

WHEREAS, the Consultant agrees to continue to provide the services to the County in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

1. Recitals

The above recitals are true and correct and are incorporated herein by reference.

2. Amendment

This Amendment No. 5 renews the Agreement for the period of December 20, 2021 through December 19, 2022.

3. Agreement

The Agreement, Amendment No 1, Amendment No. 2, Amendment No. 3, Amendment No. 4 and Amendment No. 5 represent the entire understanding between the Parties.

4. Terms and Conditions

Except as otherwise stated herein, the terms and conditions of the Initial Agreement shall constitute the terms and conditions of this Agreement. A true and correct copy of the Initial Agreement is hereby incorporated by this reference.
