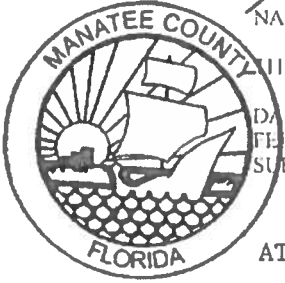

Authorization for the Chairman to execute Amendment 002 to the State FY 20/21 Home Care for the Elderly (HCE) grant agreement with Senior Connection Center, Inc.

Enabling/Regulating Authority

Background Discussion

On June 16, 2020, the Board of County Commissioners approved the State FY 20/21 funding agreement for the Home Care for the Elderly Program and subsequently, on March 23, 2021, Amendment 001 to this agreement was also approved increasing funds due to a state wide increase to this program.

HCE program funds are provided by the State through the Senior Connection Center, Inc., encouraging the provision of care to the elderly in family type living arrangements and private homes as an alternative to institutional placement by providing monthly financial subsidy payments to the caregiver.

An unanticipated surplus of funds resulted from the unexpected termination of clients from the program due to their death or transfer into a skilled nursing facility. Amendment 002 occurs

after the end of the service delivery date of June 30, 2021, and allows the resulting decrease in subsidy service usage of \$8,255.05 to be transferred to other counties that had a deficit in this program.

There is no county match to this program.
