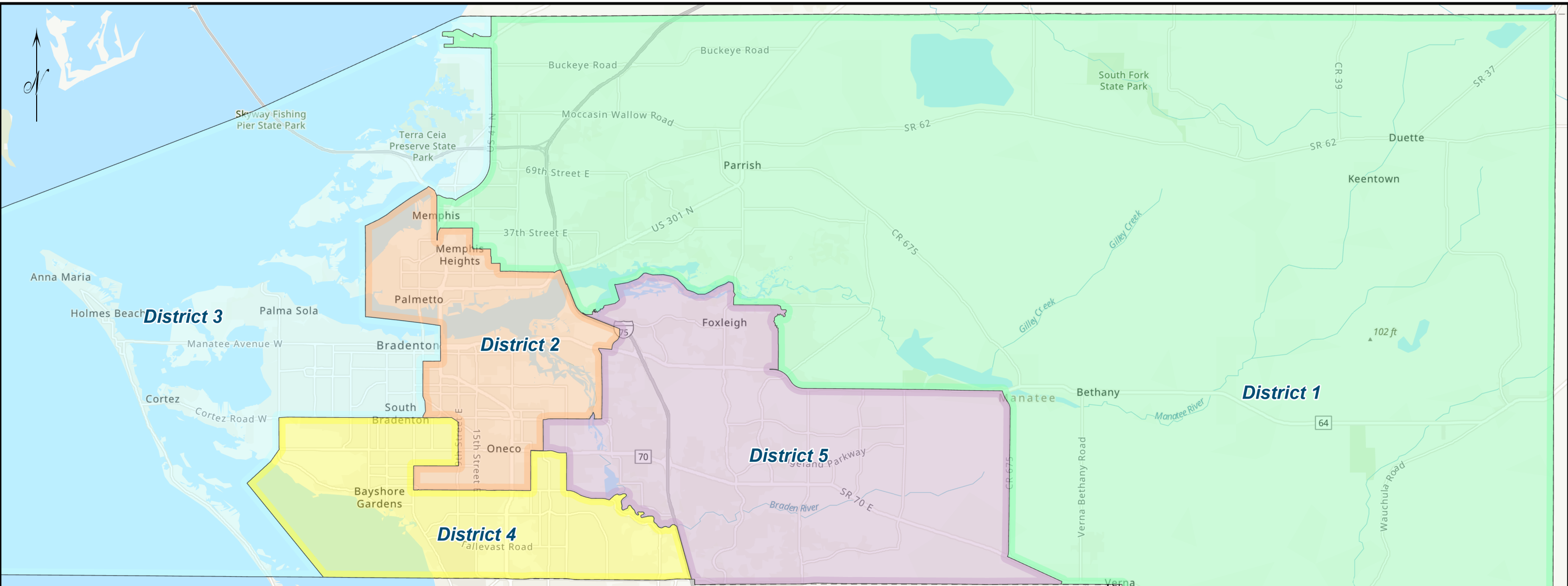

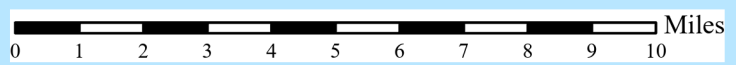
Amount and Frequency of Recurring Costs
