Dear County Administrator Hopes and Manatee County Commissioners:

The two redistricted maps the Manatee County Commissioners have posted for public view and comment do not adequately reflect the spirit of Florida's Fair District criteria. A better map should be drawn to provide the best representation for the County.

## **Why are we spending taxpayer's money to hire an unbiased professional to draw the districts - and a law firm to review it - if we are going to allow politicians & special interests to carve up our community for their benefit?**

Under the FL Fair Districts Criteria maps must:

- Equally divide the population
- Be drawn with partisan fairness
- Be drawn to provide fair representation to minorities
- Be compact and contiguous

Although the commissioners discussed some desired outcomes in terms of specific areas of the county they would like to represent, the core stated goals during each of the Redistricting conversations were:

- Redistricting should balance the county's population, while accounting for continuing rapid growth in Districts 1 and 5,

- Preserve the minority character (representation) of District 2 and,
- Be legally defensible.

Map A1 preserves and increases the existing minority representation of District 2; Map B reduces minority representation by 2%. Map A1 balances the county's population, while accounting for rapid growth in Districts 1 & 5; Map B does not. Map A1 was drawn by a consultant, presumably making it more legally defensible; Map B was introduced by Commissioner Vanessa Baugh.

### **Concerns:**

**Minority Cracking of District 4:** District 4's population is currently ~37% non-white. Both proposed maps crack District 4's minorities into the other districts, diluting representation by up to 10%.

**Partisan Cracking of both District 2 and 4:** In District 2, Map B reduces the % of voters registered as Democratic by 12%, changing the District from majority Democrat to majority Republican. In District 4, Democratic voters are reduced approximately 5% in both maps, eroding the current D/R split to lean more heavily Republican.

**Map B does not reduce the size of District 5 in anticipation of future growth.** If districts were divided equally, each would have 20% of the population. In Map B, District 5 has 20.1% in total population and 20.5% in voting age population, more than average currently.

**Map B divides the coastal communities into 4 different districts.** Just as the BoCC is attempting to give a stronger voice to the rural area by having one primary commissioner, the coastal areas deserve appropriate representation with primarily one commissioner representing it.

### **Recommendation:**

**Under the Federal Voting Rights Act the minority vote shall neither be “cracked” (diluted) or “packed” (concentrated). Under the Florida Constitution's Fair Districts criteria, neither minority or partisan representation shall be “cracked” (diluted) or “packed” (concentrated).**

**Have the consultant refine Map A1, as a consultant drawn map is expected to be legally defensible. This should be a major consideration and Map A1 could easily be refined to account for the above referenced concerns.**

Dear County Administrator Hopes and Manatee County Commissioners:

The two redistricted maps the Manatee County Commissioners have posted for public view and comment do not adequately reflect the spirit of Florida's Fair District criteria. A better map should be drawn to provide the best representation for the County.

Under the FL Fair Districts Criteria maps must:

- Equally divide the population
- Be drawn with partisan fairness
- Be drawn to provide fair representation to minorities
- Be compact and contiguous

Although the commissioners discussed some desired outcomes in terms of specific areas of the county they would like to represent, the core stated goals during each of the Redistricting conversations were:

- Redistricting should balance the county's population, while accounting for continuing rapid growth in Districts 1 and 5,
- Preserve the minority character (representation) of District 2 and,
- Be legally defensible.

Map A1 preserves and increases the existing minority representation of District 2; Map B reduces minority representation by 2%. Map A1 balances the county's population, while accounting for rapid growth in Districts 1 & 5; Map B does not. Map A1 was drawn by a consultant, presumably making it more legally defensible; Map B was introduced by Commissioner Vanessa Baugh.

### **Concerns:**

**Minority Cracking of District 4:** District 4's population is currently ~37% non-white. Both proposed maps crack District 4's minorities into the other districts, diluting representation by up to 10%.

**Partisan Cracking of both District 2 and 4:** In District 2, Map B reduces the % of voters registered as Democratic by 12%, changing the District from majority Democrat to majority Republican. In District 4, Democratic voters are reduced approximately 5% in both maps, eroding the current D/R split to lean more heavily Republican.

**Map B does not reduce the size of District 5 in anticipation of future growth.** If districts were divided equally, each would have 20% of the population. In Map B, District 5 has 20.1% in total population and 20.5% in voting age population, more than average currently.

**Map B divides the coastal communities into 4 different districts.** Just as the BoCC is attempting to give a stronger voice to the rural area by having one primary commissioner, the coastal areas deserve appropriate representation with primarily one commissioner representing it.

### **Recommendation:**

Under the Federal Voting Rights Act the minority vote shall neither be "cracked" (diluted) or "packed" (concentrated). Under the Florida Constitution's Fair Districts criteria, neither minority or partisan representation shall be "cracked" (diluted) or "packed" (concentrated).
