Background Discussion

On May 26, 2022, the County entered into Agreement No. 22-R078489BB with Transit Solutions, LLC dba TSI Video for the provision of Manatee County Area Transit (MCAT) Onboard Camera System for an estimated amount of \$481,971.00 per agreement.

Since execution of the Agreement on May 26, 2022, the County has issued four (4) change orders to provide for additional material and installation of existing equipment on paratransit vehicles, add extended hardware warranty support and to eliminate the remaining contingency fund.

Given the continued need for MCAT Onboard Camera Systems yearly maintenance and Nexview Pro License, the Public Works Department estimates the annual expenditure for these services to be approximately \$41,000.00. The department is requesting funding for Agreement No. 22-R078489BB to be directly associated with the Board of County Commissioners (BCC)–approved departmental budget. The direct association with the

BCC—approved departmental budget will allow the Public Works Department to realize greater efficiencies and have autonomy to use Agreement No. 22-R078489BB in order to expeditiously facilitate the necessary services on an as-needed basis. Any deviation in funding will require a budget amendment be brought before the Board of County Commissioners for approval prior to the issuance of the requested Release Order.
