

THIS AMENDMENT, entered into between Senior Connection Center, Inc., hereinafter referred to as the "agency" and Manatee County, a political subdivision of the State of Florida, hereinafter referred to as the "subrecipient", amends Contract No. CCE-25/26-MAN.

The purpose of this amendment is to:

- 1) increase Section 3, Contract Amount, by **\$73,529.51**;
- 2) increase Section 5, Source of Funds, by **\$73,529.51**;
- 3) revise and replace ATTACHMENT III, Budget Summary.

1. Section 3, is hereby amended to read:

**3. Contract Amount**

The agency agrees to pay for services according to the conditions of **ATTACHMENT I** in an amount not to exceed **\$2,010,236.51** subject to the availability of funds.

2. Section 5, is hereby amended to read:

**5. Source of Funds**

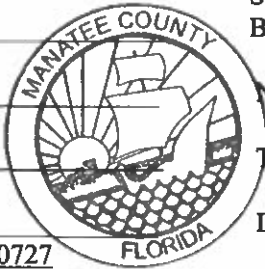

RESOLUTION B-26-077  
AMENDING THE ANNUAL BUDGET  
FOR MANATEE COUNTY, FLORIDA  
FOR FISCAL YEAR 2026

WHEREAS, Florida Statutes 129.06, authorizes the Board of County Commissioners to amend its budget for the current fiscal year as follows:

- a) Appropriations for expenditures in any fund may be decreased and other appropriations in the same fund correspondingly increased, provided the total appropriations of the fund are not changed.
- b) Appropriations from reserves may be made to increase the appropriation for any particular expense in the same fund, or to create an appropriation in the fund for any lawful purpose.
- c) Unanticipated revenues, including increased receipts for enterprise or proprietary funds, may be appropriated for their intended purpose, and may be transferred between funds to properly account for the unanticipated revenue.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida that the 2025-2026 budget is hereby amended in accordance with FS 129.06 as described in the description and specified in the budget adjustment batch file listed below:

Description: Appropriates \$73,530 of additional grant revenue in the Grants fund from the Senior Connection Center Inc (SCC) for the FY25/26 Community Care for the Elderly (CCE) program. Also, transfers \$8,170 from reserves for in the General fund to the Grants fund for the required local match increase.

**Background Discussion**

On June 17, 2025 the Board of County Commissioners approved the Sate FY 25/26 funding agreement for the Community Care for the Elderly (CCE).

On November 4, 2025 the Board of County Commissioners approved Amendment 001 increasing the funding amount by \$136,369.00 as a result of Legislative appropriations received from the Department of Elder Affairs.

Amendment 002 is a second increase of \$73,529.51 as a result of a surplus in the program in another county within our Service Provider Area which consists of Manatee, Hillsborough, Polk, Hardee and Highlands Counties. There is a 10% match to this program that has

already been approved with the original agreement. Due to Manatee County running a program deficit, the additional funds will make sure we do not have to reduce or stop in home services through the contract end date of June 30, 2026.

CCE funds are provided by the State to provide services such as but not limited to Case Management, Emergency Alert Response, Homemaker, Medical Transportation, Personal Care, Home Delivered Meals and In-Home Respite to persons 60 years of age or older to prevent or delay institutional placement. Case Management and Medical Transportation are provided by the County directly through Community & Veterans Services and Manatee County Area Transit respectively. All other services are provided through subcontract.
