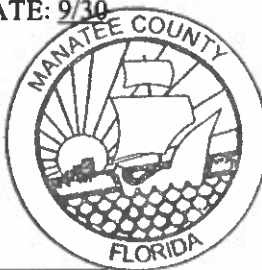

**Background Discussion**

On June 17, 2025 the Board of County Commissioners approved the State FY 25/26 funding agreement for the HCE program.

On November 4, 2025 the Board of County Commissioners approved Amendment 001 to the funding agreement increasing the funding amount to a total of \$215,617.00

The purpose of Amendment 002 is to add two additional service types in order to aid in spending down the additional funds. The two service types titled by the state are Specialized Medical Equipment, Services and Supplies and Material Aid which will allow for the provision of items such as incontinent supplies, durable medical equipment and hurricane ready packs.

The HCE program is for individuals aged 60+ who have a caregiver providing 24 hour care in the home and it provides a financial stipend to the caregiver as an alternative to nursing

home or other institutional care settings. Clients have to meet income and asset guidelines to be eligible along with the 24 hour care.

The addition of the services will allow for the utilization of the additional funds.
