Background Discussion

On September 3, 2024, through a competitive solicitation, the School Board of Sarasota County entered into Agreement No. 24-0115 with Stewart Tennis Courts & Fencings, Inc. for fence installation and repair services, valid through September 2, 2026.

On August 25, 2025, the County issued Piggyback Blanket Purchase Order Agreement No. T2500560 to Stewart Tennis Courts & Fencing, Inc. for the installation, maintenance and repair of fencing throughout Manatee County on an as needed basis. Currently, the Piggyback Blanket Purchase Order is structured by which Release Orders are issued as needed, based on project demands, including new fencing installations, maintenance of existing fences, and necessary repairs and are directly tied to and funded through the requesting departments Board of County Commissions (BCC)-approved budget.

Given the ongoing need for fencing installation, maintenance and repairs on fences throughout Manatee County, the Property Management Department estimates the annual expenditure to be approximately \$1,000,000.00. To improve efficiency and provide greater autonomy in utilizing these services, the Property Management Department is requesting that funding for the Piggyback Blanket Purchase Order be directly associated with each requesting department's BCC-approved budget. Any deviation in funding will require a Budget Amendment to be presented to the BCC for approval prior to the authorization of additional services.
