Background Discussion

The Sarasota/Manatee Metropolitan Planning Organization (MPO) is a regional transportation planning agency, and Manatee County is a member agency with three County Commissioners serving as voting members on the MPO policy board. The policy board is served by a few committees that review and provide recommendations regarding certain regular business items prior to policy board consideration. One of those committees is the Citizen Advisory Committee (CAC) which is composed of citizen representatives appointed by member agencies. There are six voting CAC members representing Manatee County with four at-large and two for the unincorporated area only. The current CAC roster with term dates is attached for reference.

There is currently one vacancy for Manatee County, and it is an at-large seat with no special category requirement. Staff ran an advertisement soliciting applicants seeking appointment to fill the vacancy. The County received nine applications between Mar 14 and Apr 1, 2026. Each applicant appears to be eligible. Table 1 presents a summary of the applicants, and each application is also attached.

Staff request the Board appoint one applicant to fill the vacant at-large CAC seat.

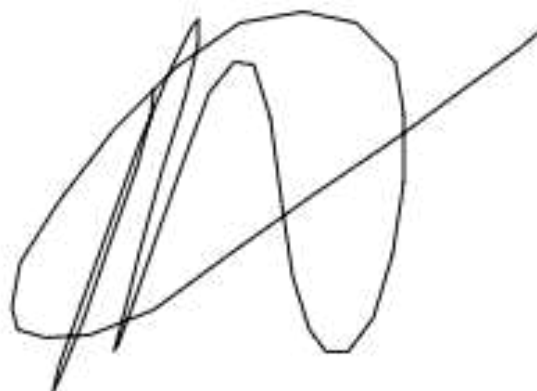
