Dear Property Owner:

It has come to the attention of the Public Safety Department that the required structure numbers (house numbers) are not visible/posted on your structure on your property located at 5706 E 10TH ST BRADENTON, (DP# 5825300154). This constitutes a violation of Section 742 (Structure Numbering Standards) of the Manatee County Land Development Code.

Perhaps you were not previously aware of this regulation. This letter is intended to give you written notice of such violation, and to give you an opportunity to correct this violation within fourteen (14) days of receipt of this letter. In order to correct the violation(s), the structure numbers must be posted and clearly visible from the street.

If after fourteen (14) days the violation has not been corrected it will be necessary to schedule a hearing before the Manatee County Code Enforcement Board or Special Master.

In accordance with Florida Statutes, the Code Enforcement Board of Special Master may assess fines up to \$250.00 per day for each day the violation exists beyond the date set for compliance.

At this hearing you will be expected to enter a plea of in violation or not in violation. If you enter a plea of in violation, ou may be given an opportunity to eliminate the violation short of a fine being imposed. If you enter a plea of not in iolation, this matter will be forwarded to the Code Enforcement Board for a hearing on 12-APR-00, at 9:00 a.m. at the oard Chambers, 1st floor, Manatee County Administrative Complex,1112 Manatee Ave. W., Bradenton, Florida.

A plea of not in violation may be entered in writing, and may be mailed to Manatee County Code Enforcement Division ost Office Box 1000, Bradenton, Florida 34206. If it is received before the date set for hearing before the Special Master, ou will not have to appear at the Special Master hearing, but you should appear at the meeting of the Code Enforcement pard. IF YOU FILE A WRITTEN PLEA OF NOT IN VIOLATION, YOU WILL NOT RECEIVE A SEPARATE NOTICE OF

If you do not enter a written plea of not in violation and fail to appear at the Special Master hearing, or if your case is warded to the Code Enforcement Board and you fail to appear at the Code Enforcement Board meeting, you will be emed to admit the violation and appropriate penalties may be imposed.




### STRUCTURE NUMBERS

742.11. All assigned structure numbers shall remain affixed to the respective structure and maintained by the property owner.

742.13. All existing principal structure(s) shall post structure numbers within six (6) months of the effective date of this Code meeting the requirements of Section 742.7.2.5.

742.7.2.5. Prior to the issuance of a Certificate of Occupancy or Completion, the structure for the principal use shall have its assigned structure address number clearly posted on the structure or in the case of a structure which is not visible from the road or is set back from the road more than 100 feet, the numbers shall be placed on a sign or mailbox near the driveway entrance and shall be clearly visible from the road. In addition to the number being posted at the driveway entrance, it shall also be placed on the structure. Numbers 3" in height (minimum) for residences and 6" in height (minimum) for businesses shall be used.
