**PUBLIC HEARING APPLICATIONS (INDIVIDUAL CONSIDERATION)**

1. **VA-03-06 - GLASGOW DOCK** (Dorothy Rainey, Planner) (To be CONTINUED to December 17, 2003)  
Approval of a variance to allow a reduction of the minimum side yard setback from 8.0' to 0.7' for a dock, reducing the east side yard for a lot in the RSF-4.5/CH (Residential Single-Family-4.5 dwelling units per acre/Coastal High Hazard Overlay) zoning district at 4827 Palmetto Point Drive, Palmetto (Lot Area = ±12,465 sq. ft.).
2. **SP-03-04 - KAREN CAMPBELL/CAMPBELL BEAUTY SALON** (Dorothy Rainey, Planner)  
Approval of a Special Permit to allow a one-chair beauty salon as a conditional home occupation. The site is located at 5425 36<sup>th</sup> Street East in the A-1(Suburban Agriculture, 1 dwelling unit per acre) zoning district (± 0.50 acres).
3. **SP- 02-12 TIBERIU & IOLANDA STEINBRECHER (TIBIOLI INC.)/VETERINARY HOSPITAL**  
(Stephanie Brooks, Planner)  
Approval of a Special Permit to allow a 2,520 square foot Veterinary Hospital in the A-1 (Suburban Agriculture, 1 dwelling unit per acre) zoning district. The site is located at 5719 SR 64 (± 0.41 acres).

Rules of Procedure for this public hearing are in effect pursuant to Sections 502.6.6 and 505 of the Manatee County Land Development Code. Copies of these sections of the Code are available for review, or purchase at cost, at the Planning Department, 4th Floor, Manatee County Administrative Center, 1112 Manatee Avenue West, Bradenton, Florida.

According to Florida Statutes, Section 286.0105, any person desiring to appeal any decision made by a Hearing Officer with respect to any matter considered at this Public Hearing will need a record of the proceedings, and for such purposes he may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.
