and Cortez Fishing Village for afternoon sessions

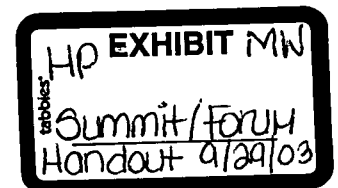
PURPOSE: To coordinate and enhance historical preservation efforts throughout
