1. VA-10-02 – EXECUTIVE VIEW, INC./ LOT 13 HARBOUR LANDINGS

Request: Approval of a variance to allow an existing pool screen cage to remain 3.2 feet from the required 5 foot side yard setback for an existing accessory structure to a single-family home in Harbour Landings Subdivision. The site is zoned PD-R/CH (Planned Development Residential/Coastal High Hazard Overlay). The site is at 12622 Safe Harbour Drive, Bradenton (0.266 ± acres).

Approval of a Special Permit to allow an unmanned unoccupied 150' Unipole-type Personal Wireless Service Facility (PWSF). The site is in the RSF-4.5/WP-E/ST (Residential Single Family 4.5 dwelling units per gross acres/Evers Watershed Protection Overlay District Reservoir/Special Treatment Overlay District) zoning district. The site is located at 5625 Whitfield Avenue, Sarasota, FL (38.62 ± acres).

Copies of these sections of the Code are available for review, or purchase at cost, at the Planning Department, 4th Floor, Manatee County Administrative Center, 1112 Manatee Avenue West, Bradenton, Florida.

According to Florida Statutes, Section 286.0105, any person desiring to appeal any decision made by a Hearing Officer with respect to any matter considered at this Public Hearing will need a record of the proceedings, and for such purposes he may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.
