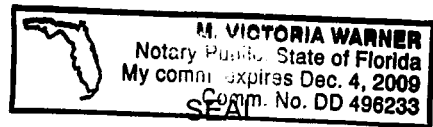
BEFORE ME, the undersigned authority, personally appeared Robert Schmitt, who, after having first been duly sworn and put upon oath, says as follows:
