Manatee Port Federal Accomplishments

- AUTHORIZATION FOR REIMBURSEMENT, SOUTH CHANNEL EXTENSION
 - Omnibus Appropriations Act, FY 2008
 - SEC. 126.
 - Section 156 of Public Law 108–137 is amended by inserting "or reimburse" after "non-Federal share of the cost of the project" in paragraphs (2) and (3).
- FEDERAL MAINTENANCE OF MANATEE HARBOR BASIN
 - Water Resources Development Act OF 2007
 - SEC. 5001. MAINTENANCE OF NAVIGATION CHANNELS.
 - (a) IN GENERAL.—Upon request of a non-Federal interest, the Secretary shall be responsible for maintenance of the following navigation channels and breakwaters constructed or improved by the non-Federal interest if the Secretary determines that such maintenance is economically justified and environmentally acceptable and that the channel or breakwater was constructed in accordance with applicable permits and appropriate engineering and design standards:
 - (1) Manatee Harbor basin, Florida.







Manatee Port Federal Accomplishments Cont'd

- TIGER II GRANT
 - Port Manatee, FL: \$9,000,000
- MARINE HIGHWAYS GRANT
 - Manatee/Brownville Seabridge awarded **\$3.3 million**, close to one half of the total amount available for Marine Highway Grants. Only seven grants awarded nation wide.
- O&M FUNDING
 - FY 07: **\$2,600,000** * an increase of \$2,600,000 over the budget
 - FY 08: **\$2,969,000** * an increase of \$521,000 over the budget
 - FY 09: **\$2,483,000**
- CONSTRUCTION FUNDING
 - FY 10: **\$100,000** * an increase of \$100,000 over the budget
 - FY 11: \$350,000 * an increase of \$350,000 over the budget
- SEAPORT SECURITY FUNDING FY 07 FY 11
 - \$15,513,924
- AMERICAN RECOVERY AND REINVESTMENT ACT (Stimulus)
 - Port Security Grant: \$998,542
- Completion of Feasibility Study, improvements to main Tampa Bay Channel
- Outbound range tower installed in 2008/2009 by U.S. Coast Guard
- Legislation proposing restriction on ports of entry for food products amended to not impact Del Monte activities.


