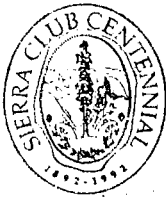


Dear Planning Commissioner Bedford,

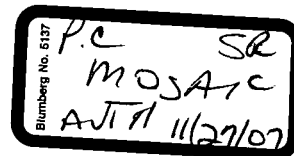
