

### Dear Manatee County Commissioners,

Thank you for the opportunity to have had a few minutes to address the commission on your consideration of increases in impact <u>fees.</u> This is a long letter, to cover all that is pertinent to this issue, so I want to make my most important point up front.

You are the gate keepers for the School Boards attempt to raise impact fees and you will take some political heat for it no matter how you vote. I want you to understand that what the school board is doing is asking for impact fees that will not be shared with roughly 10% of your constituents county wide, who are very active voters. These are the parents of the nearly 4,000 students who attend Manatee Counties Public Charter Schools, that under the laws of the State are in every way public schools, with no tuition and open to all students.

2,000 of these students attend Manatee School for the Arts, where I am chairman. Our parents are very active, they know what is going on. They pay the current local sales tax add-on for capital outlay, yet their children do not share in the tax revenue and they are extremely angry about that. I promised to take up their cause and I have, but I expect you will hear from them soon too and at the next election, they have long

## memories. They expect you to insure that the School Board Shares any revenue you approve.

Fees or taxes differ little in the mind of voters. It is, to them money they must send to government and that they don't have for their budgets. Sadly many will never hear the concerns you clearly expressed as to the burden that is to those of lower income in our community. Our parents know the difference between impact fees, property and sales taxes. They also do not trust the school board.

As Constitutional officers you are tasked with making tough decisions in finding the revenue to provide the numerous services the taxpayers expect, but sadly most tax payers forget they are paid for by them until the tax bill arrives. Each State is different in demographics and laws but there are things you may want to consider.

First lighter populated communities like Manatee County versus Sarasota often must accept lesser services and conveniences from government, or pay a much higher per-capita tax to support their initial and maintenance costs. At our waterfront vacation home in Maine property taxes are nearly four hundred percent the mill levy of Manatee County. This is due in no small part to the fact that Maine is so sparsely populated that there is only one area code for the entire state, 207! For those higher taxes we get no garbage or trash pickup, a volunteer fire department and our water and sewer are a private well and septic system! Manatee County is in another century by comparison.

As communities grow from small to large the residence pay to buy the land and construct roads, bridges, schools and parks, sewer and water projects. The accumulation of the infrastructure we have today took over a century and several generations of tax payers paying for it all to achieve. I have been contributing for over half a century. Those taxes hire policemen; buy police cars and build jails and court houses. Most of this (not hiring police) are capital expenses. Repairing the roads and the school buildings, bridges and sewers is not a capital expense and capital revenues from sources like impact fees cannot by law be used for these things. This massive century long growth of infrastructure comes with a heavy price of maintaining it all with operating funds. The larger the infrastructure the higher that cost is. It must be budgeted for if you do not want it to deteriorate. Previous boards have left you to do that heavy lifting.

One can see that those who have lived here for over half a century, as I, and many have, paid for many of these things when they were first purchased. Manatee Avenue and U.S. 41 were two lanes when I was a child. I-75 did not exist. There was one rickety wooden bridge to Anna Maria. There was no county wide water system or sanitary sewer system; there still is none like ours in Sarasota!

Previous Commissioners like Dan McClure had the foresight to see the water wars coming that would destroy the counties agriculture businesses and lack of sewers would damage our environment, water ways, and tourism, our two largest businesses. Those who came later benefited from the items those of us who grew up here have paid for. Impact fees are a way of making newcomers, pay their share of the initial capital expenditures for all that is here they will enjoy and to fund their impact on the community to build the newly needed roads, schools, bridges, etc for them.

Without these impact fees we will have to live with an insufficient future infrastructure, or raise fees and taxes on those who have already paid to build these things in the first place to build more for the new development. You will be forced to raise other taxes and to diverting limited operating monies to just maintain the status quo. Do not feel bad. Most governments are good at building the bridges to the future; most fail to fund their upkeep. Think of it as buying a vacation home. The purchase price is only the first expense, and then begins the recurring tax payments and the upkeep. Over the life of the home those items often cost more than the original purchase price. So too does municipal upkeep.

You are all good people, trying to do the right thing. But you need to understated this and deal with it. Sadly you are only a small part of the tax burden, the taxpayers love to hate. Few people pay attention to their tax bills. I do! Few look at their city taxes, and most important the school taxes and its mega-budget. The school board manages more revenue and collects more taxes than the Manatee County Commission, and every city in the county combined! It costs as much, or often more, to educate a child from a family in a subsidized low income house as from a waterfront mansion. They and their families all use the same roads and hospitals. But the guy in the mansion not only pays his families tab, he

pays for several families. Middle class Manatee gets devastated. We will not solve poverty in this county by just subsidizing the poor. We will do it with better education and better higher paying jobs. Low income housing is a band-aid and a badge of failure, not compassion.

We cannot subsidize a bus ride at 1300% of what is collected in bus tickets when an Uber cab to a doctor, grocery store, or job would cost a quarter of that amount for the poor. Better yet a good higher paying job would pull people out of poverty so they could buy their own car. And no, the five people on a typical, largely empty bus, starting and stopping and belching diesel soot while slowing traffic is not taking people off the road nor aiding Al Gore's crusade. It is insane. How many do you know who ride the bus? I assume you know how much it all costs.

The Manatee County school board does not care about your problems, or the political heat you will take. They do not even want to try to keep the soon to expire extra sales tax for desperately needed capital outlay. They have determined that it will fail in a referendum in these politically hostile times.

A while back they asked me and the other charter schools to back the issue, and despite the malfeasance that put them in this fiscal mess, we were ready to back it with the votes from nearly four thousand charter school families. They had not shared any of that local revenue as Sarasota did with their charter schools. So all we asked was include us in the revenue you will get from taxing the parents of our students and we will reluctantly back a tax hike. I told them with our backing it was still a long shot on the sales tax, without it, it was doomed. The board and

superintendent seem to think it will be easier to let you take the taxpayer heat and do the dirty work for them by doing an impact fee first and offering it as a straw man to get the sales tax later. You will be needed, by law, to get their impact fees. You will be blamed for that part of the money you will not control. You will need all the support you can get to avoid a political nightmare next year.

I am asking you to let me help and to do several things.

- 1. Insist that the School board commit in writing to share, on a per student basis, every dollar in capital money they collect from any new impact fees in return for your approval. You owe this to your constituents who have nearly four thousand students in total choice, tuition free, Florida public charter schools. In law we are in every way Florida public schools, we deserve fairness and equity.
- 2. Conditioned upon item one please approve the impact fees for the schools.
- 3. Approve impact fees for the county and at least consider the 100% level. New roads are not free and very operating dollar you spend on new roads is a dollar you do not have to repair old roads.
- 5. Allow me and others to offer you a long list of new revenue sources.
- 6. Instruct staff to work more closely with our legislative representatives. I walked across the street to Senator Bill Galvano's office and spoke to his

secretary after I addressed you. I am told he will not personally be introducing, nor sponsoring bills, but his position can be very helpful to us and other counties to deal with the states attempt to shift the burden of revenue to the counties and cities and away from the state. Face it cutting taxes is far more fun than raising them and the state has the power to force it on you.

Use our advantage at having a Senate President to leverage more authority to levy fees, and other sources of revenue. If you don't you will find yourself in a situation of crumbling infrastructure, and angry taxpayers, and unlike the school board you will not have someone to bail you out.

As to angry tax payers, they morph in to angry voters and I have never seen the electorate angrier. Given nearly four thousand students in charter schools I work with, I have an email list approaching seven thousand voters. I can't tell them how to vote. But they expect me to inform them how the school board and county commissioners voted and leave it to them to decide if they and their children were treated fairly. With the same button that will send this email to each of you with one tap, I can send it to all of those voters. I would much rather tell them how proud I was that you stood up for them and did the right thing pushing the School board to be fair and share.

7. One final word. We are not Sarasota. Most of us do not want to be Sarasota. I could move there if I thought it was so great. Trust me even the sushi is better in Palmetto than Sarasota. Our demographics are

different. You really cannot do a one for one comparison without correcting for the demographics. We have a great community, you can make it better. Please do.




## Current Elementary School Utilization








## **Current Middle School Utilization**
